### Message from the Chief of Police

Chair Gilmer and Members of the Port Hope Police Services Board:

I am pleased to present to you the annual report for the Port Hope Police Service for 2022. You will find information contained in this report that is presented to you to satisfy legislative requirements as well as information that will give a thorough insight into our 2022 operations within the community.

2022 was the second year of working towards fulfilling the priorities as laid out in the 2021-2023 Business Plan as created by the Board from community-wide submissions. The service has managed to make strides towards satisfying the requirement contained within the Plan.

Although there were instances of illness within our ranks, the PHPS was able to keep our staffing levels near normal and seamlessly deliver policing services to our community.

After the announcement of retirement of Chief Bryant Wood in the fall of 2022, Chief Tim Farquharson joined the Port Hope Police Service on March 1, 2023, from the Peterborough Police Service where he has served since 1986, most recently as Deputy Chief. He has extensive experience in Operations and Criminal Investigations, including a lengthy tour of duty in the Intelligence and Drug Investigation Units. He is a Fleming College graduate and has taken courses at Trent University and Carleton University. He is also a graduate of the Rotman Police Leadership Course through the University of Toronto, and he attended the FBI Police Leadership Program in the United States.

Chief Farquharson is a member of the Canadian Association of Chiefs of Police Drug Advisory Committee and is also the current Chair of the Ontario Association of Chiefs of Police (OACP) Substance Advisory Committee. He is a member of the OACP Organized Crime Committee, and the Director of Zone 3 for the OACP. He is an active member of many other agencies and committees dealing with the challenges of substance use.

Over the course of his successful career, Chief Farquharson has received many accolades, including the Lieutenant Governor's Medal of Bravery and he has been invested as a Member of the Order of Merit of the Police Forces.

When he is off-duty, Chief Farquharson spends a great deal of time raising funds and awareness to support various community agencies and stakeholders in their tireless efforts to help our marginalized and vulnerable population.

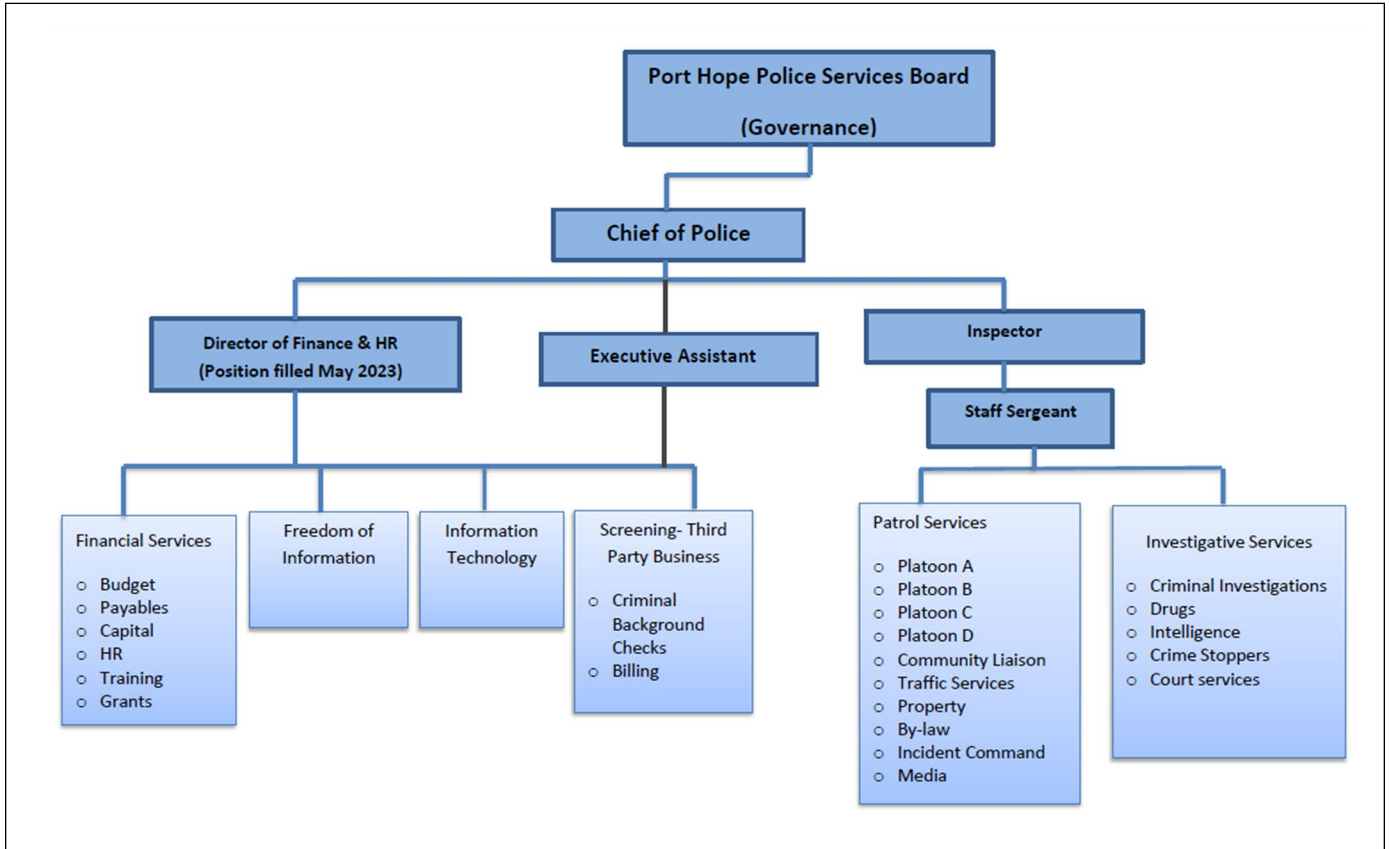

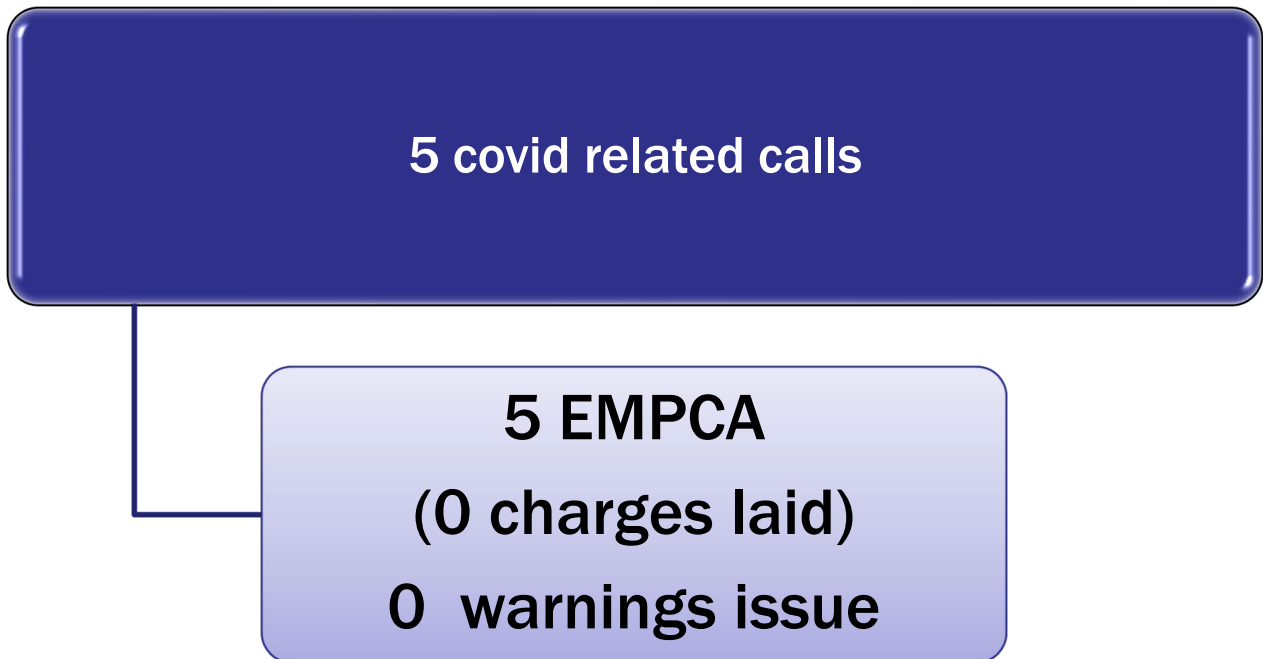

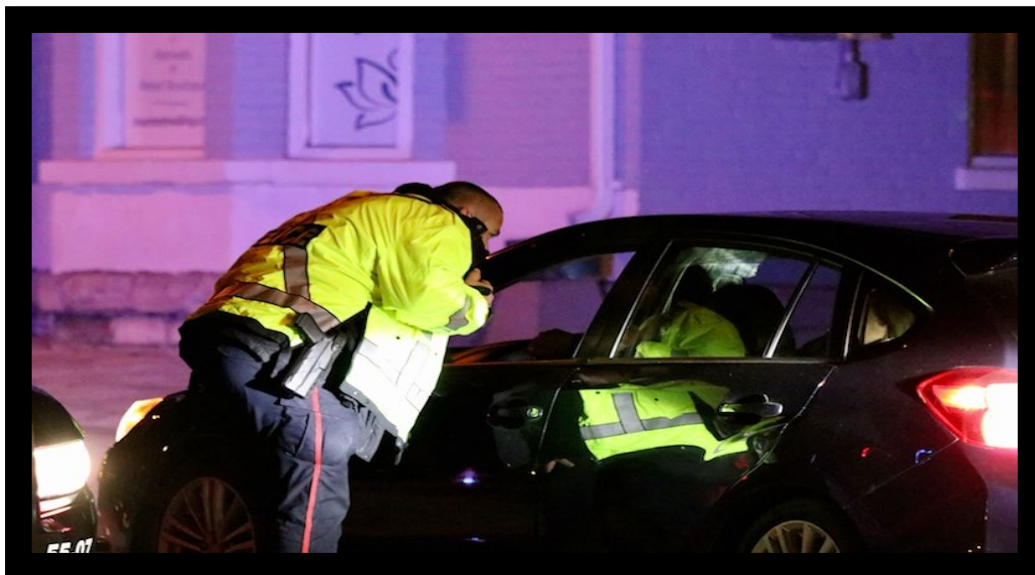

## Major Call Types:

For every incident, the Police Service reports to Statistics Canada using uniform crime reporting codes (UCR). The data from this reporting is used for crimes analysis, resource planning and helps with program development. Annual 2022 statistics that follow are based on those reported UCR codes:

## Violent Crime Statistics

Violent crime calls are traumatic for families, the community and first responders. Investigations are lengthy and complex with a wide variety of resources being expended.

In 2022, we did see an increase in assaults by 78%.

Property crimes in 2022 were primarily up.

Mischief which is the willful or reckless destruction of another person's property, or the interference with another person's property rose by 4%.

Theft complaints can be broken down:

- Theft over \$5,000 there were 13 incidents.
- Theft of motor vehicles in 2022 there were 10.
- Theft under \$5,000 there were 77 calls.
- Theft from motor vehicle was reported 11 times.

## Joint Operations

The Port Hope Police Service works closely with our law enforcement partners. This relationship extends to Cobourg Police Service, OPP (Ontario Provincial police), Ministry of Transportation, Durham Regional Police Service, Ministry of Natural Resources to name a few.

The CIB department works closely with other police services in the area on projects to combat drugs, guns, gangs, human trafficking, and other criminal activity. In 2022, the department had interactions with other police services.

Throughout 2022, there were over four (4) major investigations. In March 2022, a missing person was found deceased, and it became an ongoing joint investigation with the OPP. In August, there was another suspicious death which is an ongoing joint investigation with the OPP.

## Drug Recognition

Port Hope Police Service has an officer that has been trained as a Drug Recognition Expert. This Officer is responsible for the coordination of the DRE (Drug recognition program) and SFST (Standardized Field Sobriety Test) programs within Port Hope Police Service. The Port Hope Police Service DRE officer conducted 3 DRE tests in 2022.

There were 32 incidents of impaired offences of which 16 incidents resulted in charges.

## Mental Health

The Port Hope Police Service continues to work successfully with the MHEART (Mental Health and Engagement Response Team). This team is made up of police and mental health professionals who assist on the front lines aiding individuals that need immediate mental health assistance. A Port Hope Police Officer works daily with an MHEART nurse to follow up on mental health calls. As a Service we understand the need to follow up and provide continued support to those that are willing to accept the help.

In 2022 there were 95 (2021: 169) MHEART-PHPS mental health follow-ups. This is a decrease of 44%. These follow-ups are continued support for the individual. The individual is also given a list of community services that are available.

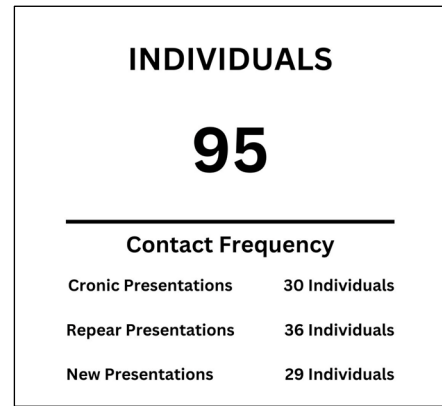

The incidents in 2022 concluded with 69% (2021: 32%) of the calls being successfully de-escalated. The Port Hope Police continue to work with community partners to provide help to those in need.

### Significant Events

#### Three Arrests made in Drug Investigation and Search Warrant

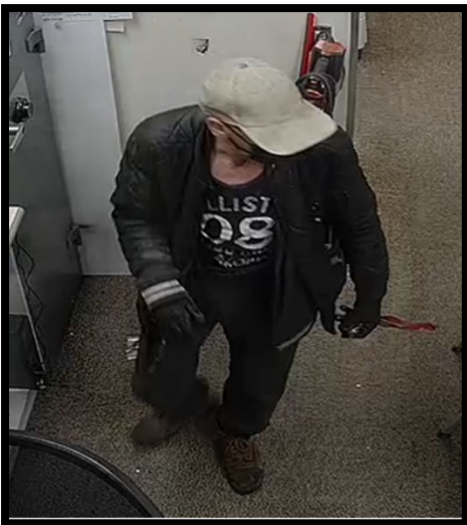
On the 1<sup>st</sup> of March 2022, as part of ongoing investigations and enforcement targeting illegal drug activity affecting our community, Police executed a Controlled Drugs and Substances Act Search Warrant at a Phillips Road apartment in Port Hope.

Members of Port Hope Criminal Investigation Bureau, Cobourg Criminal Investigation Bureau, Port Hope Police Uniform and Cobourg Police Uniform Patrol were involved in the arrest of one adult male and two adult females for possession of drugs and possession of drugs for the purpose of trafficking. As a result of the investigation and a Controlled Drugs and Substances Act Search Warrant, Police seized a small amount of Cocaine, Crack Cocaine, Fentanyl and a Prohibited Conductive Energy Weapon (Taser).

#### Break Out and Fail to Comply with Probation

On the 31<sup>st</sup> of October 2022, the Port Hope Police Service entered into an investigation for a Breakout and Theft from the Pharma-Save in Port Hope. The culprit was captured on CCTV surveillance and Police had asked the assistance of the public to help identify the suspect.

On Friday February 3<sup>rd</sup>, 2023, members of the Peterborough Police Service made an arrest in this investigation. The accused in this matter, Perry FAWM of the Peterborough area, was arrested and charged with Breaking Out and Fail to Comply with conditions of his probation.

On Friday the November 25<sup>th</sup>, 2022, Port Hope Police Service received a call for a suspicious male in Port Hope. The male was observed walking around a vehicle in the complainant's driveway and up to the front door of the residence with what Police believe to be a sophisticated scanning device contained in a backpack. Police believe the male used this device to read vehicle fobs located within the victim's residence to then steal vehicles. Police believe there were more than one person(s) involved as 3 Dodge pick-ups trucks were stolen throughout the night/early morning hours in the Municipality of Port Hope. These thefts occurred between the hours of 4:15 – 7:35am.



### Armed Robbery

On Tuesday October 18, 2022, Port Hope Police responded to an Armed Robbery in progress at the Guardian Pharmacy located at Toronto Road, Port Hope. A lone male entered the Pharmacy and brandished a firearm. He demanded money from the cash and safe, along with pharmaceutical narcotics. The male fled from Police and a brief foot pursuit ensued with officers. The male was ultimately arrested without incident. This male has been charged with several weapon offences and drug offences. Charged is 20yr old Royon Henry -McLean of the Scarborough Ajax area.

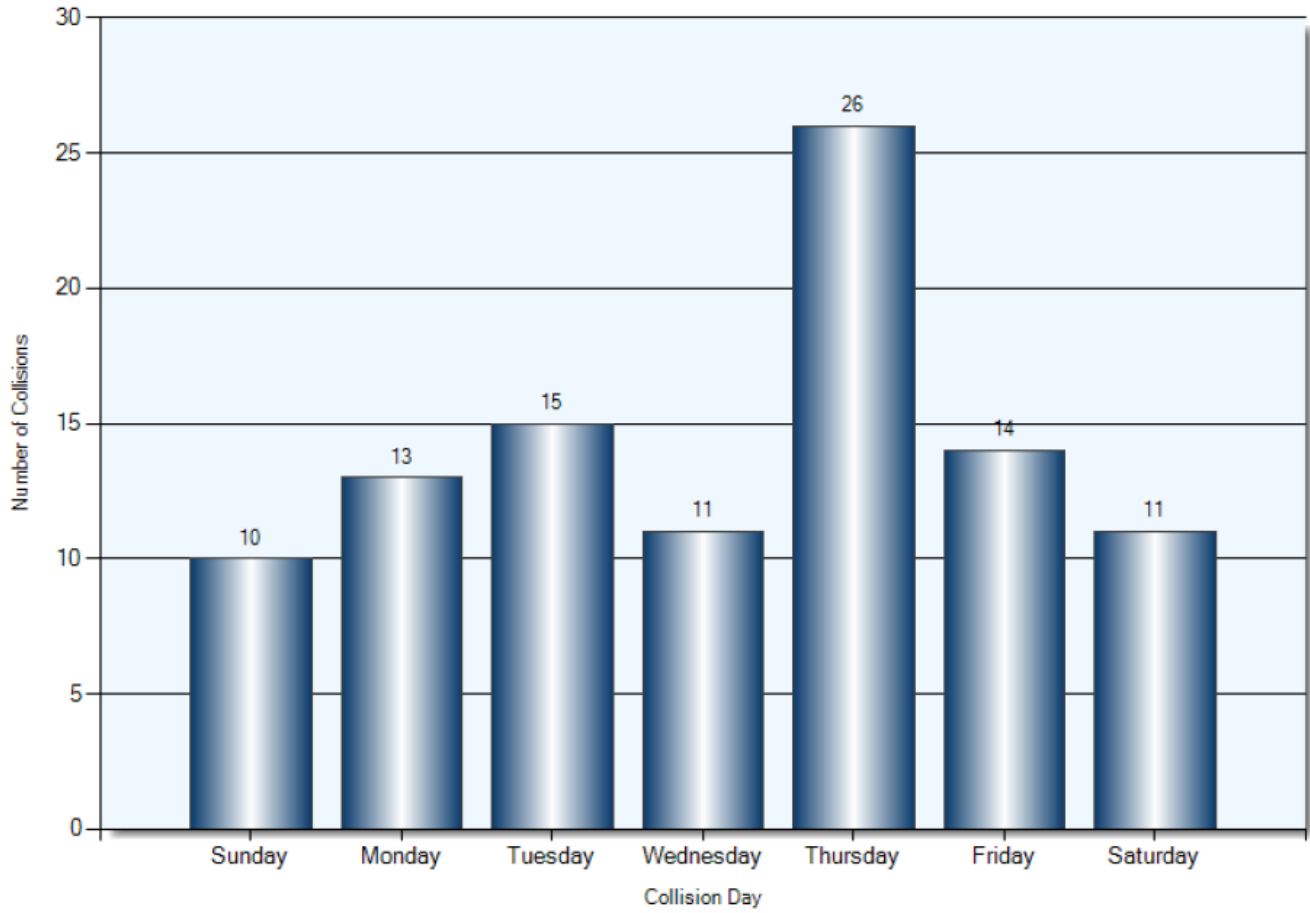

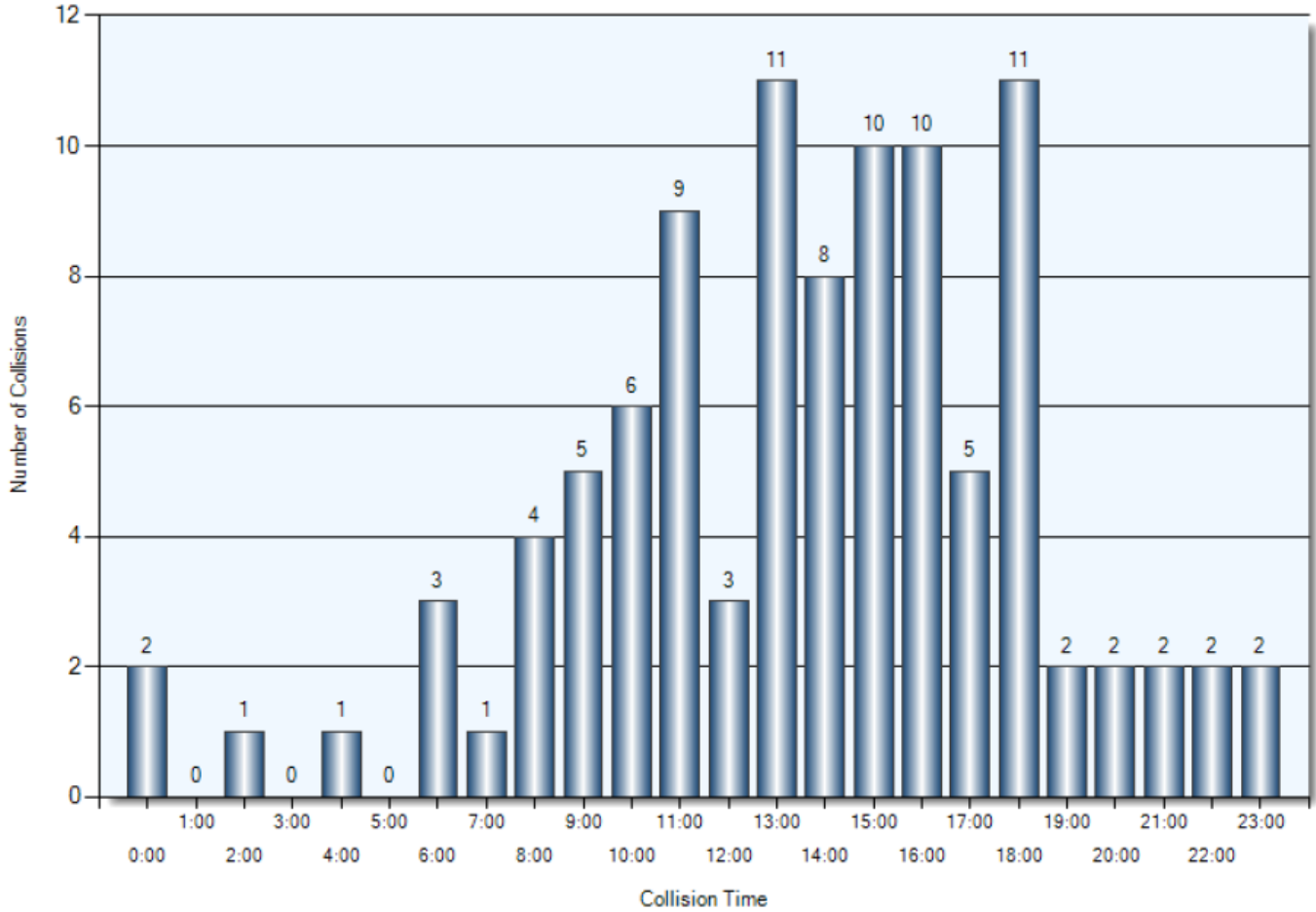

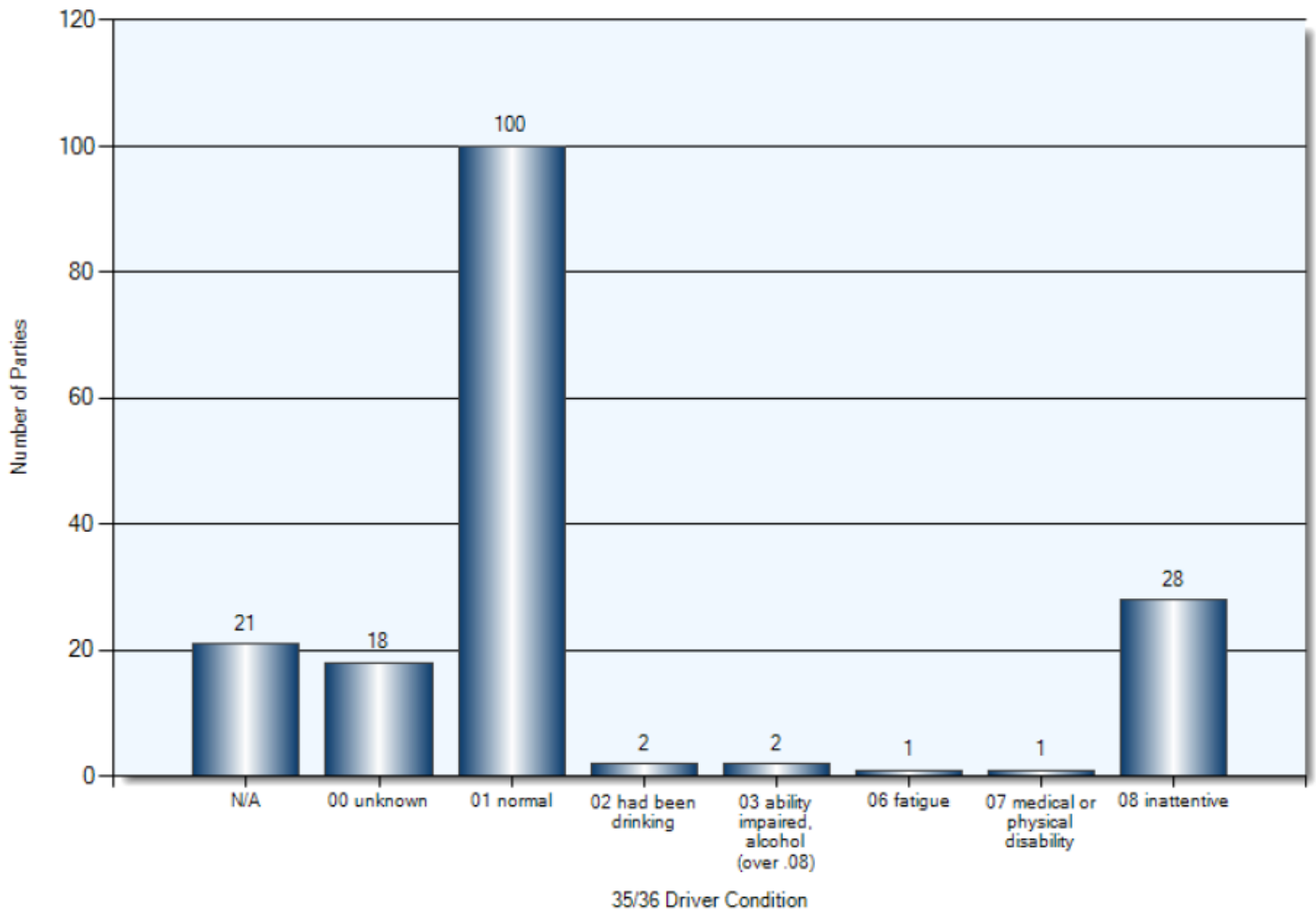

## Collision Time



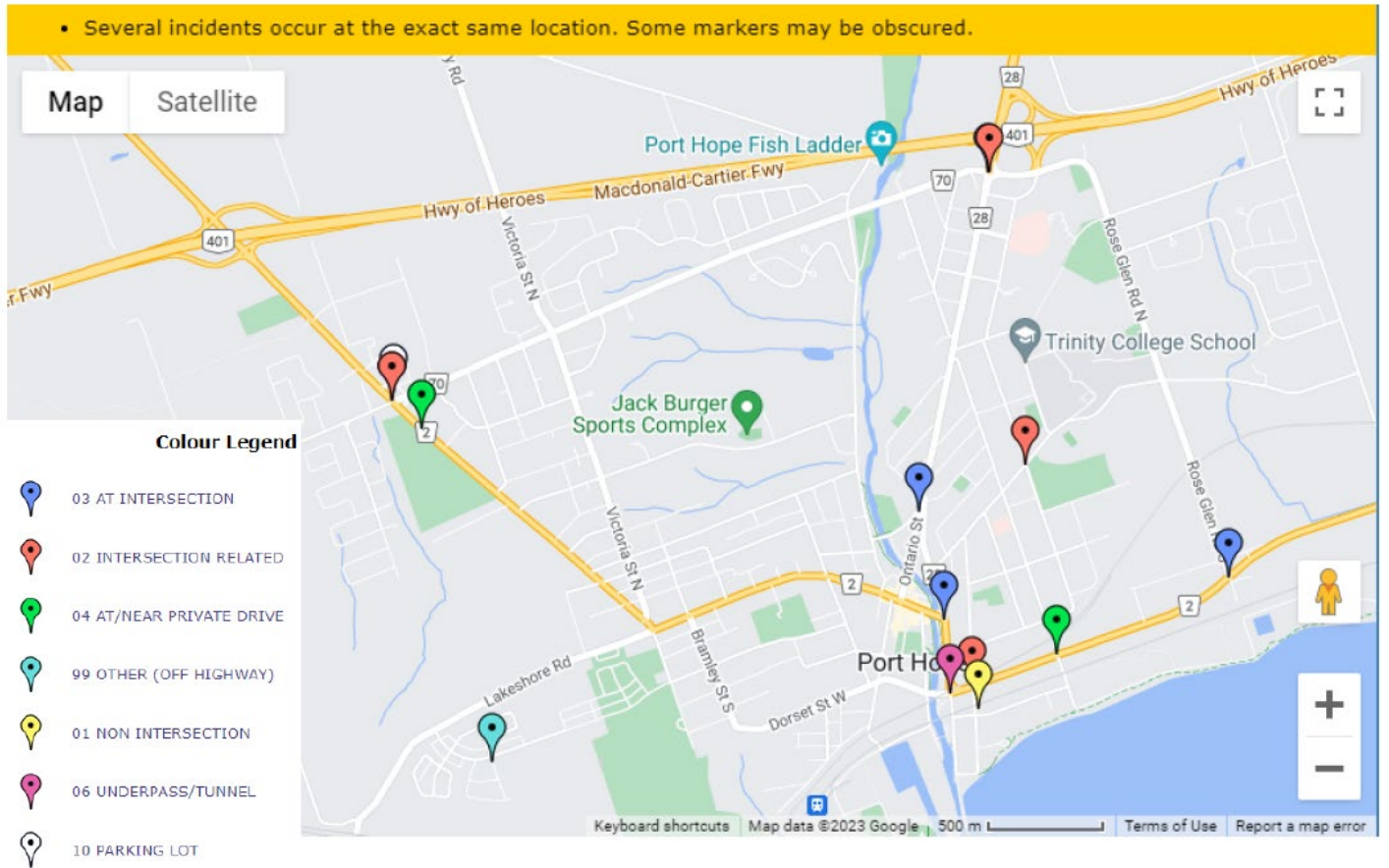


## Driver Condition





## Collisions Involving Injuries

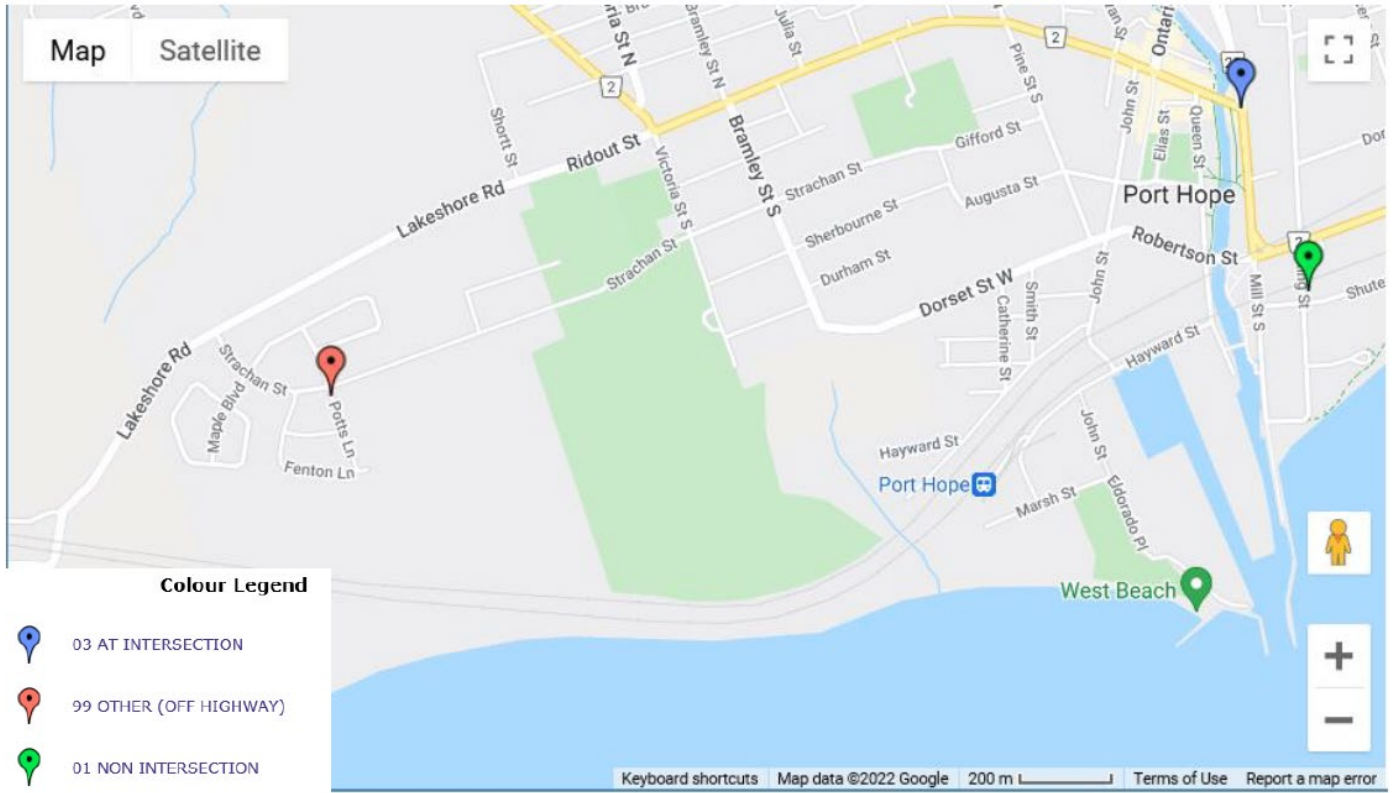

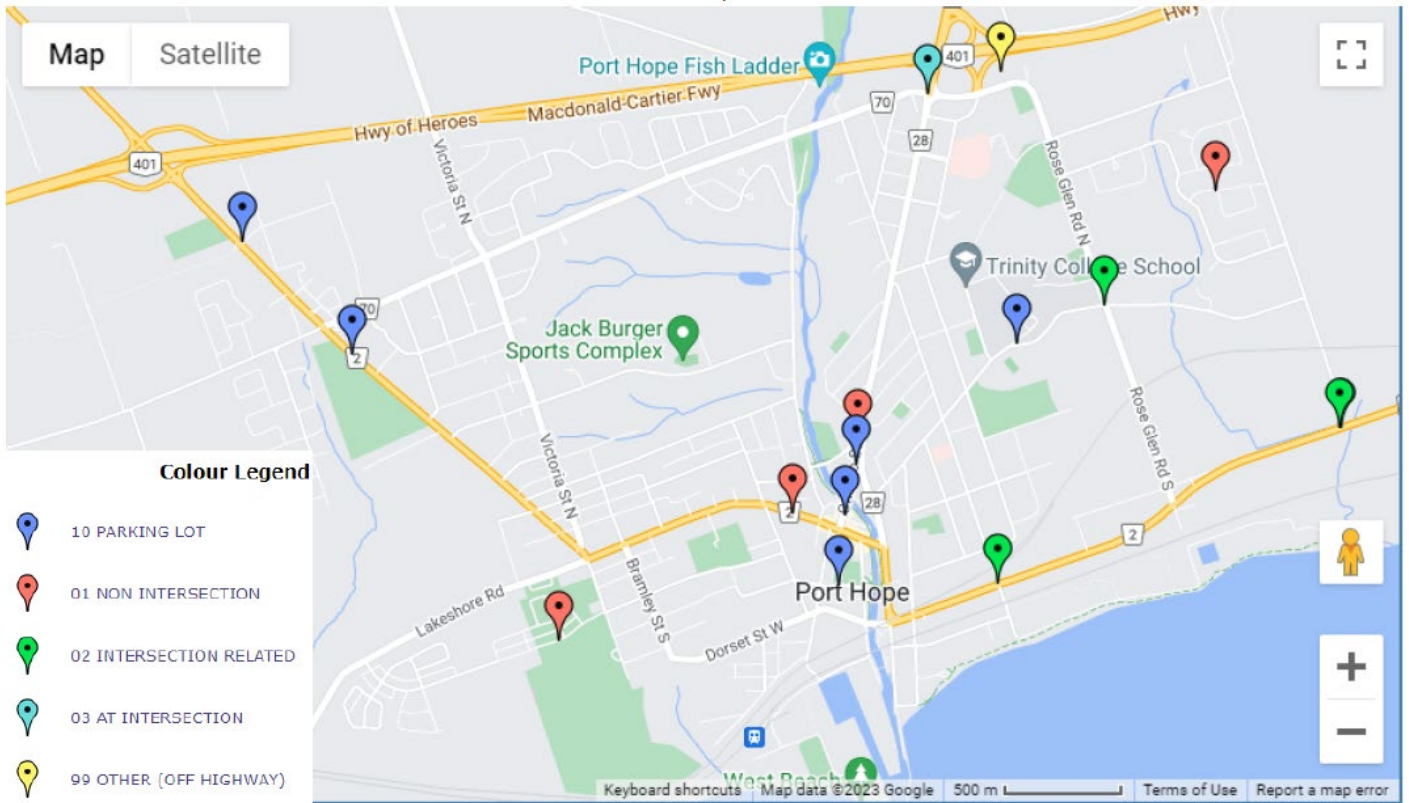
## Collisions Involving Pedestrians

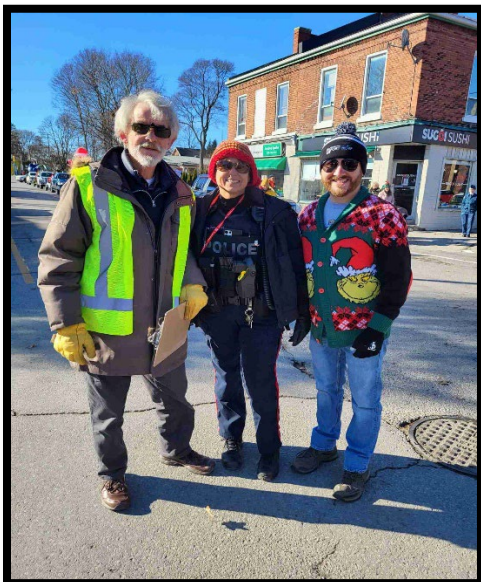

## Financials

The 2022 Port Hope Police Service (PHPS) budget highlights are based on preliminary internal statements as external audited year-end financial statements were not finalized at the time of this report. Overall, the Police service was under budget with a surplus of \$44,601 at the writing of this report.

This section does not include screening revenue or expenses, see page 31 for screening data.

**Revenue:** Actual revenue of \$156,423 was \$21,070 above the budgeted amount of \$135,353.

**Expenses** Actual expenses of \$6,173,362 was \$241,479 above the budgeted amount of \$5,931,883. These additional expenses were primarily due to: R&M for buildings and grounds, R&M for vehicles, patrol operations supplies, overtime salaries, and fuel.

**Capital:** In 2022, the following capital projects were completed: A new truck replaced an older SUV, a new cruiser replaced an older cruiser, and new tasers replaced older versions.





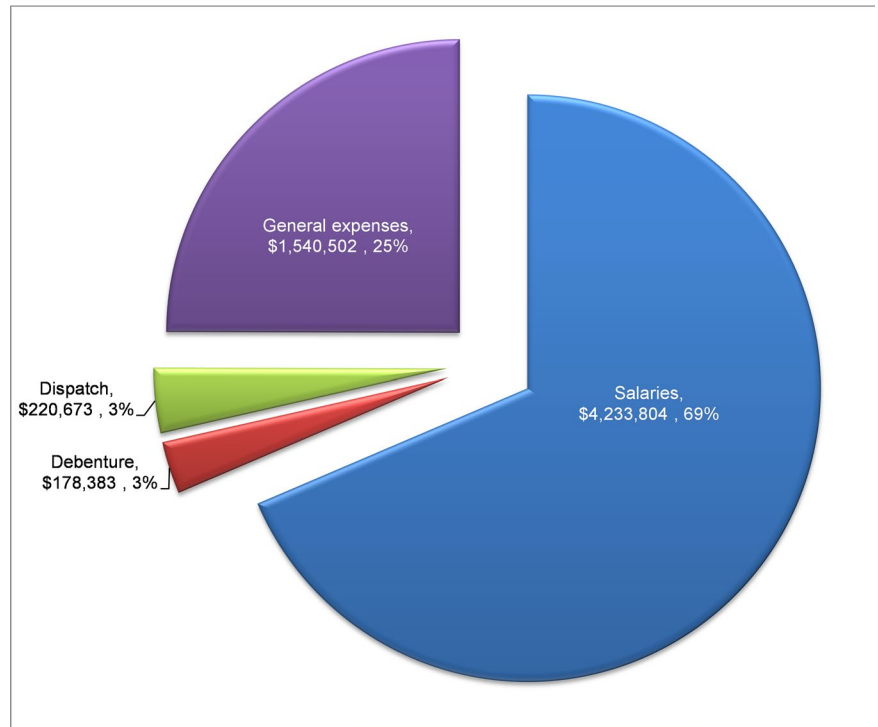

## Breakdown of Expenses

69% of the 2022 budget went to salaries. Salaries are negotiated between the Port Hope Police Board and the Port Hope Police Association.

General expenses are items such as heat, hydro, gas, vehicle expenses, building maintenance, information technology maintenance agreements and other items which made up 25% of the annual expenses.

The debenture made up 3% of the expenses in 2022 and dispatch made up 3%.



## Screening:

Port Hope Police Service has several clients for which third party criminal record checks are done, primarily for employment purposes.

In 2022, screening earned revenues of \$534,435 and incurred expenses of \$269,425 which resulted in a profit of \$265,010 available to transfer to the municipal policing reserve.

Monies from the municipal policing reserve are used to fund police capital items such as police cruisers, guns, body armour, speed signs and to offset operating capital as determined by the Port Hope Police Service Board.



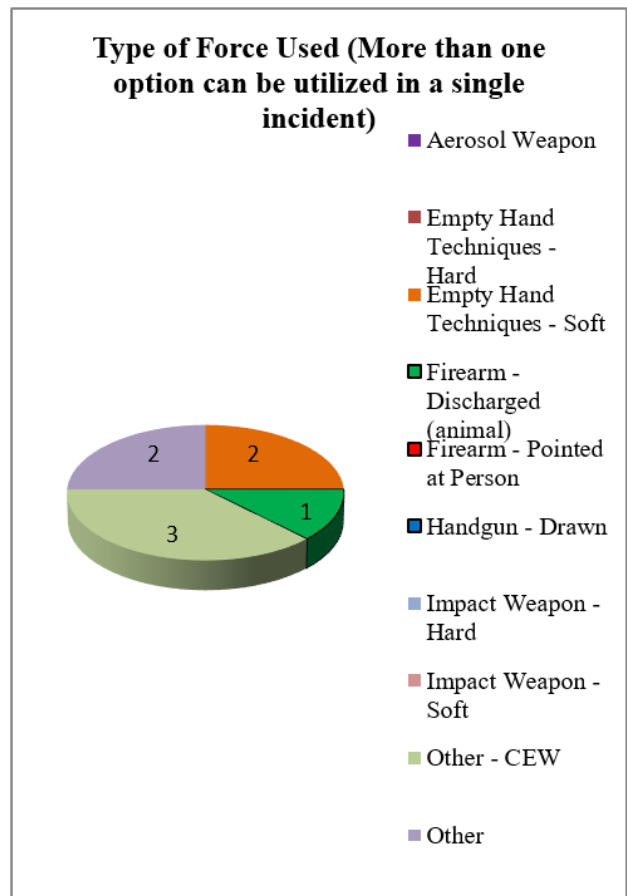
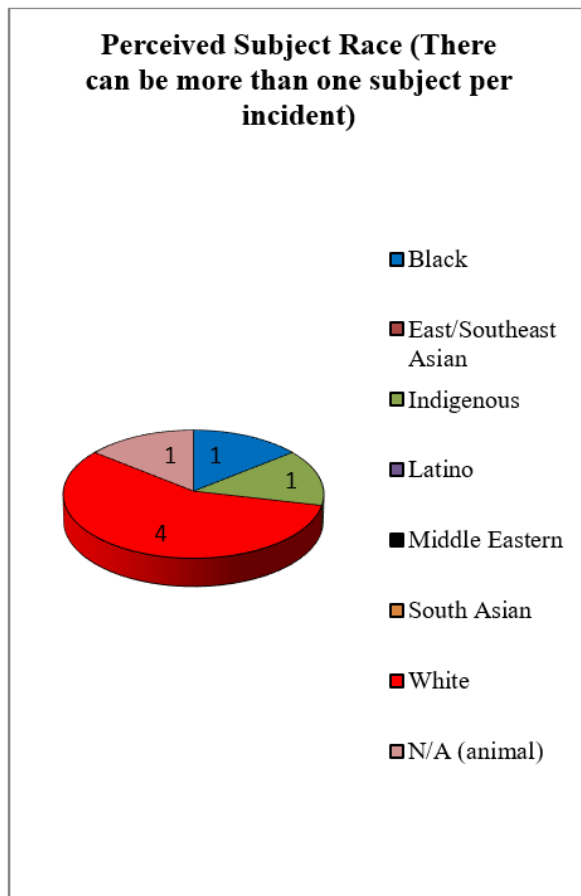
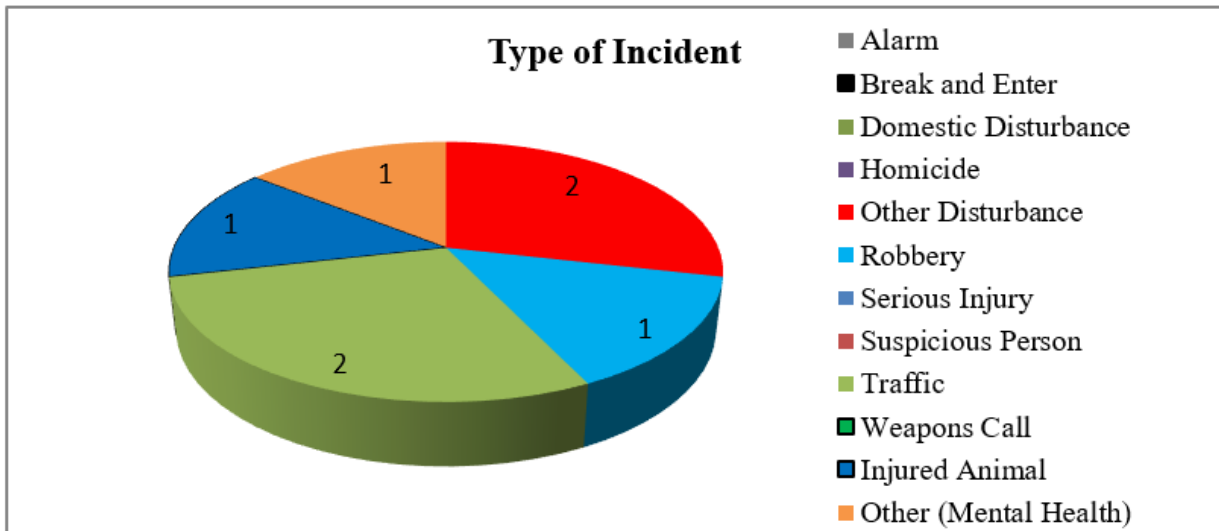

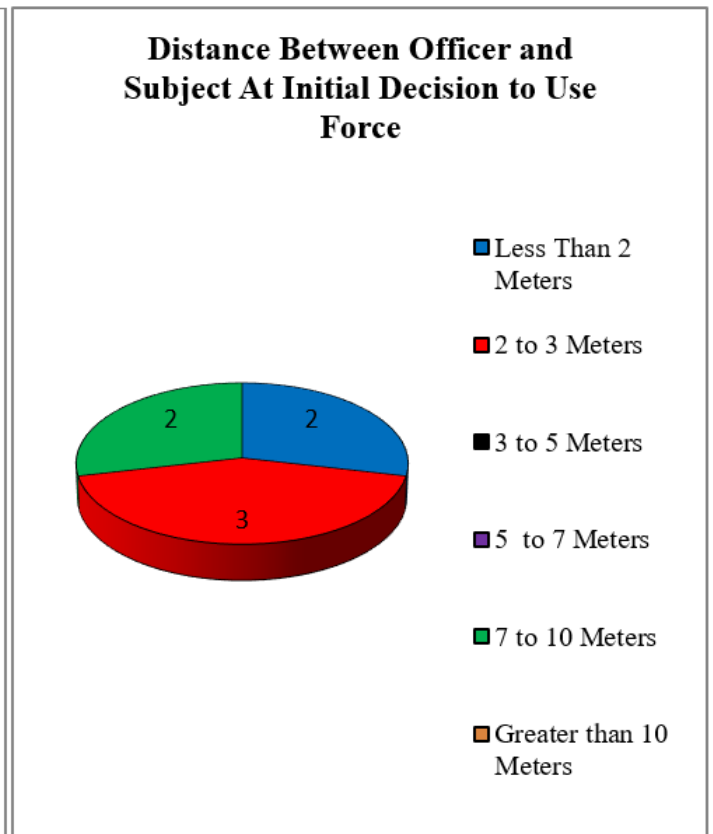
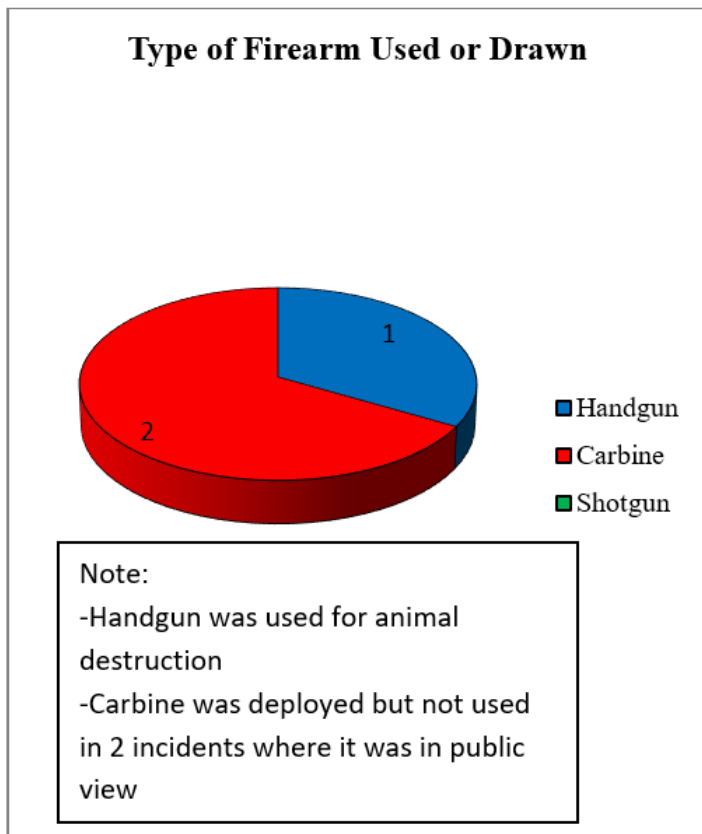
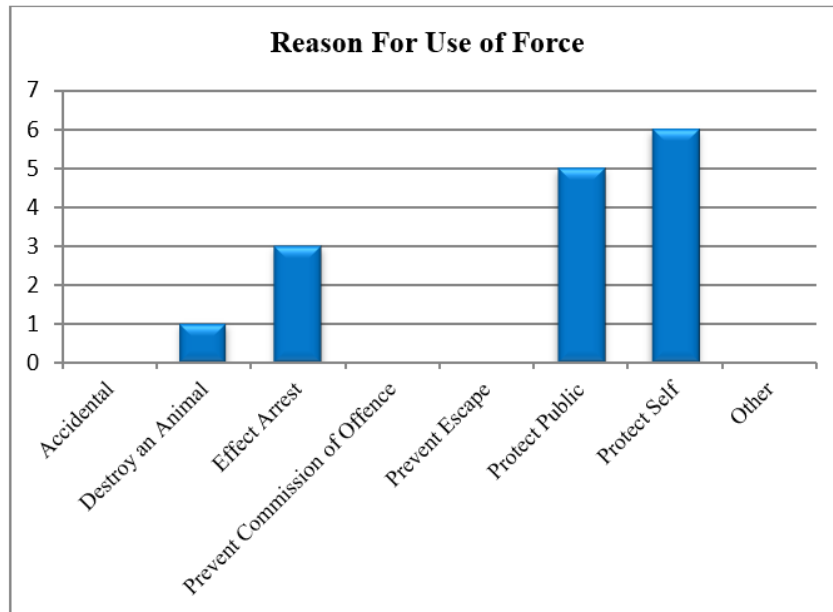
## Use of Force

## Public Complaints

The Port Hope Police Service is committed to handling complaints against police in a professional manner for both the individual complainant and the subject police officer. Three officers are committed to investigating public complaints. As required under the Police Services Act, Part V, investigators for the Port Hope Police Service are the Staff Sergeant, Sergeant in charge of the Criminal Investigations Unit and a Frontline Sergeants. The Inspector is the liaison with the Office of the Independent Review Director.

The following is a breakdown of Part V complaints under the Police Services Act.

### Local Inquiry

### Chief's Complaint

Under section 76 of the Police Services Act, the Chief of Police may initiate a complaint about one of his/her officers that would require an investigation. After the investigation, the matter is then referred to the Chief for resolution. There were 0 Chief's Complaints in 2022.
