Message from Chief of Police



Chair Gilmer and Members of the Port Hope Police Services Board:

I am pleased to present to you the annual report for the Port Hope Police Service for 2021. You will find information contained in this report that is presented to you to satisfy legislative requirements as well as information that will give a thorough insight into our 2021 operations within the community.

2021 was the first year of working towards fulfilling the priorities as laid out in the 2021-2023 Business Plan as created by the Board from community-wide submissions. Already the service has managed to make strides towards satisfying the requirement contained within the Plan.

As the second full year of the Covid-19 pandemic wrapped up our operations had mostly returned to normal. With the introduction of vaccines during the spring and with the provincial priority to vaccinate emergency services workers, our employees were able to continue to do their jobs in the

face of the anxieties created by this disease. Although there were instances of illness within our ranks, the PHPS was able to keep our staffing levels near normal and seamlessly deliver policing services to our community. I am personally extremely proud of all of our uniformed and civilian members for their efforts and commitment to stay safe and continue to come to work in the face of the inherent risks brought about by Covid-19.

At the beginning of the year there were significant personnel changes with the retirement of Deputy Chief Strongman in late 2020 and the promotion of Inspector Andrews to Second-In-Command along with the promotion of Staff Sergeant Marino. We have also brought on board a number of new Constables in a mix of recruits as well as experienced officers. Most notably, after an eight-year assignment, Constable Tammie Staples rotated out of the Community Liaison role and has been assigned to Community Safety and Well-Being which will focus on community mental health, homelessness and substance abuse and addiction in alignment with Northumberland County's Community and Safety Well-being Plan.

As we move into 2022 there are signs that the pandemic will move to the endemic phase and that life will move to a more normal state.

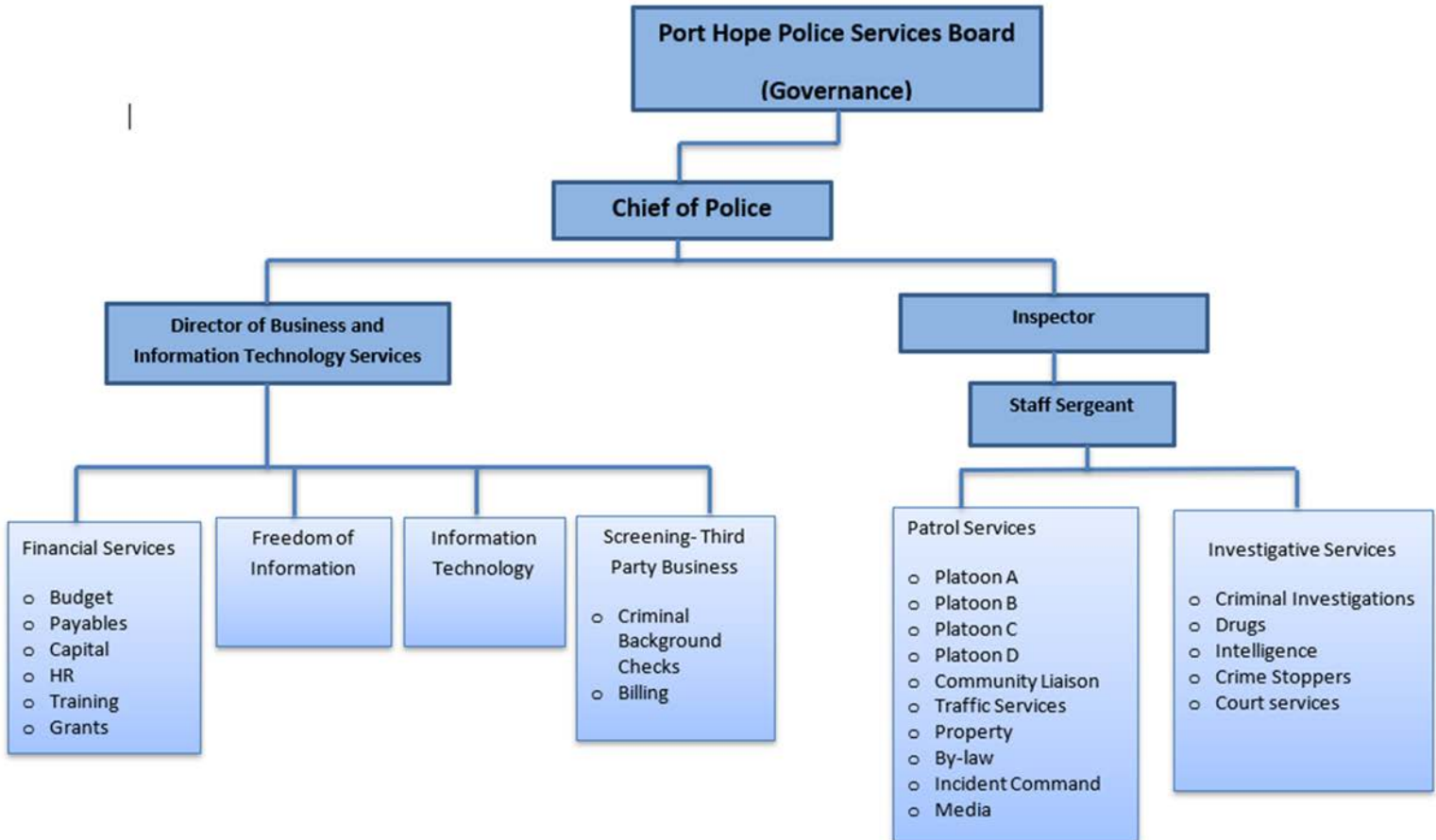

Awards and Honours

Award for Port Hope Police Officer, Tammie Staples



The Ontario Association Chiefs of Police (OACP) is pleased to announce that Constable Tammie Staples of the Port Hope Police Service (PHPS) is the recipient of the **2021 OACP School Resource Officer (SRO) Award of Excellence**.

This award is presented in recognition of the accomplishments of a member of a police service who consistently demonstrates outstanding engagement and achievement within their organization and their community in terms of leadership.

Over the last seven years, Constable Staples has become an integral part of the school community in Port Hope in her role as the Community Liaison Officer (School Resource Officer) role. She delivers in-school programs, after school programs and always responds to calls from schools when students are struggling. Constable Staples participates in dozens of committees, boards, schools, and daycare and makes every effort to meet youth and to empower them to succeed.

In addition to her role with the PHPS, Constable Staples created the “Tammie’s Jammies” pajama donation drive that takes place at Christmas time. She has collected hundreds of pairs of pajamas for school kids who are kids in need and provides any surplus to the local women’s shelters.

During Prom season, Constable Staples runs a suit and dress drive to collect nice clothing for local teens that are graduating but have no access to such clothes.

Recently, Constable Staples was involved in a partnership with Northumberland County and joined a social worker who attended local schools to educate youth about the use of cannabis and other drugs, homelessness, couch surfing, and hunger. She is also in local charitable efforts, including one that distributes hundreds of coupons for meals to kid, schools, and families in need.

Each week, Constable Staples also runs a youth group drop-in centre where she provides education on bullying, sexting, social media, LGBTQ issues, Covid-19, mental health, dating or whatever the youth feel they want to discuss.

Locally, Constable Staples is recognized as not only a strong advocate for youth, but as a true community leader who cares about everyone she meets and is truly a role model for all youth in our community.





Order of Merit of the Police Forces, Chief Bryant Wood

Chief Bryant Wood was awarded the **Order of Merit of the Police Forces** by the **Canadian Association of Chiefs of Police** in a virtual ceremony July 13, 2021.

The Order of Merit of the Police Forces is a fellowship of honour based on the highest qualities of citizenship, service to Canada, to the police community and to humanity at large. Through their activities, Members, Officers and Commanders of the Order bring distinction to policing and support the concept of police cooperation in public service. These three levels of membership reflect long term outstanding service with varying degrees of responsibility.

The primary focus is on exceptional merit through contributions to policing, community development and fostering relationships among police forces in Canada and throughout the world and between police and the community. The focus is also on the total contributions made over an individual's career to date and not on a single incident or achievement.



Chief Wood began his career with the Ontario Provincial Police in 1993. He was then hired by the Port Hope Police Service in 1994, where he served in progressively responsible positions before being appointed Chief of Police in 2014.

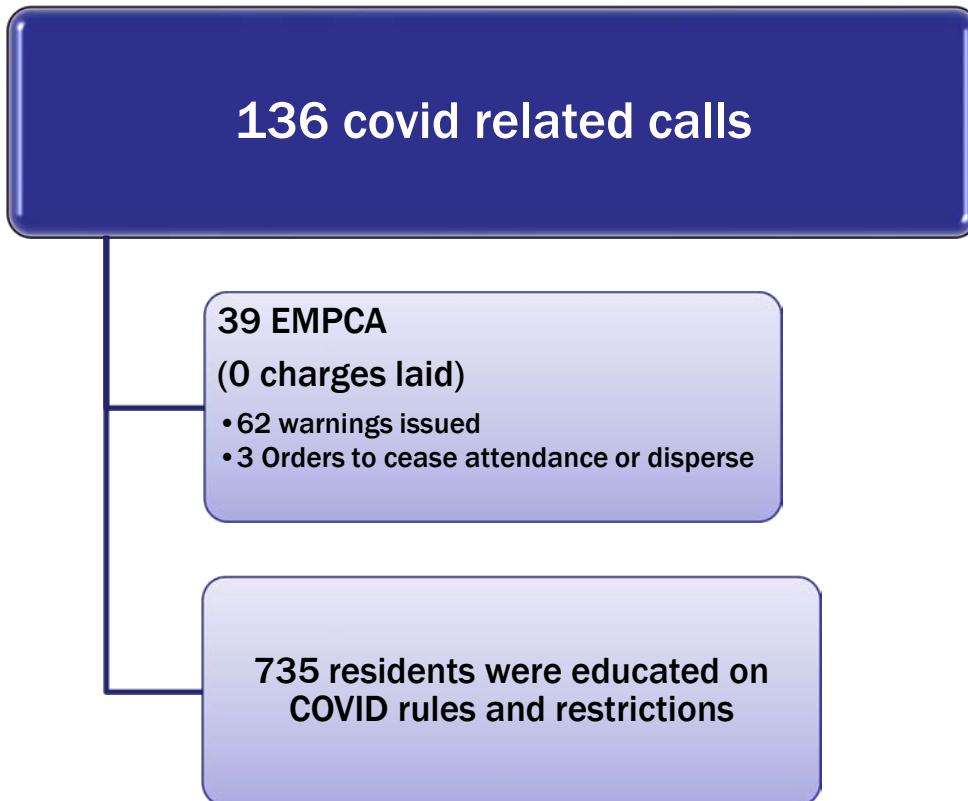

In 2021 the Service saw an increase in calls for service by 22%. Both foot patrols and vehicle patrol hours were up 128% and 29% respectively.

Major call types:

For every incident the Police Service reports to Statistics Canada using uniform crime reporting codes (UCR). The data from this reporting is used for crimes analysis, resource planning and helps with program development. Annual 2021 statistics that follow are based on those reported UCR codes:

Violent Crime Statistics:

Violent crime calls are traumatic for families, the community and first responders. Investigations are lengthy and complex with a wide variety of resources being expended.

In 2021 we did see an increase in Indecent/Harassing communications with all the social media options over 60% of the incidents were related to text mages, Facebook messages, etc.

Property crimes in 2021 were primarily down.

Mischief which is the willful or reckless destruction of another person's property, or the interference with another person's property rose by 11%.

- Theft under \$5,000 there were 79 calls
- Theft from motor vehicle was reported 8 times.

Youth Crime:

Compared to 2020 youth crime decreased in 2021. Over the past two years youth crime has been decreasing. There were 22 youth crimes cleared, 12 of them were related to drugs. The Service continues to focus on educating children in the schools on the effects of drug use. This year was the last year in the grant for the Managing Choices, Changes and Challenges Programs. The programs will continue in schools for Grades 8, 10 and 12.

CIB Notable Drug Seizure 2021:



The Port Hope Police Service Criminal Investigations Bureau executed a Controlled Drugs and Substances Act Search Warrant at a Port Hope residence as part of an ongoing investigations and enforcement targeting illegal drug activity affecting our community.

On the 8th of March 2021, as part of an ongoing joint drug enforcement investigation, members of Port Hope Criminal Investigations Bureau, Cobourg Criminal Investigation Bureau and Port Hope Police Uniform Patrol arrested one adult male and two adult females for possession of drugs for the purpose of trafficking.

Police then executed a Controlled Drugs and Substances Act Search Warrant at a Young Street residence in Port Hope.

As a result of the investigation and Search Warrant, Police seized 2.2 Ounces of Cocaine and Crack Cocaine, 2.9 grams of Fentanyl, 11.3 grams of Methamphetamine (Crystal Meth), 31 Percocet and \$100.00 cash. The estimated street value of the seized drugs is \$9,955.00.

All three were released on an Undertaking with conditions and are to appear in court in April 2021.

Joint Operations:

The Port Hope Police Service works closely with our law enforcement partners. This relationship extends to Cobourg Police Service, OPP, Ministry of Transportation, Durham Regional Police Service, Ministry of Natural Resources to name a few.

The CIB department works closely with other police services in the area on projects to combat drugs, guns, gangs, human trafficking and other criminal activity. In 2021 the department had **199** interactions with other police services.

Below is a list of just 4 joint investigations which led to arrests, throughout 2021 there were over 10 major investigations that resulted in arrests and seized drugs, cash and weapons.

- As a result of this investigation and search, police seized 22.8 grams of Cocaine, 11 grams of Fentanyl, \$1290 in cash, a .22 caliber rifle and a replica handgun. The estimated street value of the seized drugs is \$6,700.00.



- As a result of this investigation and search, police seized 58 grams of Methamphetamine (Crystal Meth), 1.75 grams of Fentanyl and \$235 in cash. The estimated street value of the seized drugs is \$6,500.00.
- Port Hope Police Service Criminal Investigations Branch and Cobourg Criminal Investigations Branch arrested two men and a woman as they exited a vehicle in a parking lot in Port Hope. Two accused were arrested without incident. One man ran from police but was quickly taken into custody and found to be in possession of a loaded 9mm Glock semi-automatic pistol with a laser sight attached to it. As a result of this investigation and search of the vehicle, police seized a quantity of suspected Fentanyl, Cocaine and Crystal Methamphetamine



- Members of the Cobourg Police Service with the assistance of the Port Hope Criminal Investigations Branch, arrested an adult male. Subsequent to the arrest, a Controlled Drugs and Substances Act Search Warrant (CDSA) was executed. As a result of this investigation and search of the residence, police seized a quantity of suspected Cocaine and Crystal Methamphetamine. Police seized approximately 120 grams of suspected Crystal Methamphetamine and 1.5 grams of suspected cocaine. Police also seized cash, weigh scales and a cell phone.

Drug Recognition:

Port Hope Police Service has an officer that has been trained as a Drug Recognition Expert. This Officer is responsible for the coordination of the DRE (Drug recognition program) and SFST (Standardized Field Sobriety Test) programs within Port Hope Police Service. The Port Hope Police Service DRE officer conducted 6 DRE tests in 2021.

There were 27 incidents of impaired offences of which 6 incidents resulted in charges.

Mental Health:

The Port Hope Police Service continues to work successfully with the MHEART (Mental Health and Engagement Response Team). This team is made up of police and mental health professionals who assist on the front lines aiding individuals that need immediate mental health assistance. A Port Hope Police Officer works daily with an MHEART nurse to follow up on mental health calls. As a Service we understand the need to follow up and provide continued support to those that are willing to accept the help.

In 2021 there were **169** MHEART -PHPS mental health follow-ups. This is an increase of **83%**. These follow-ups are continued support for the individual. The individual is also given a list of community services that are available. This is a significant increase over previous years.

The incidents in 2021 concluded with **27 %** of the calls being successfully de-escalated. Voluntary transportations to the hospital went up significantly, as we saw a shift of individuals recognizing the need for help. The Port Hope Police continues to work with community partners to provide help to those in need

Significant Events:

➤ Guns Seized

A 30-year-old male from Port Hope is facing multiple firearm related offences. Port Hope Police received information that a male had threatened his superintendent bodily harm if he was to be evicted. As a result, the Criminal Investigations Bureau authored a warrant for the residence. At 2:35 pm on Wednesday March 3, 2021, uniform patrol observed the male exit his residence, at which time he was quickly arrested without incident. The Criminal Investigations Bureau located multiple restricted and non-restricted firearms laying around the apartment. Although the male was authorized to have the weapons they were not properly secured. As a result, the individual was charged with uttering threats to cause bodily harm, adult careless storage of a firearm x13, and two counts of unauthorized possession of a weapon, one being in possession of brass knuckles, and the second charge for having in his possession an expandable baton. He was released on an adult undertaking with conditions and will appear in court in court to answer to the charges.



➤ Gas Station Break and Enters

The Port Hope Police Service had been investigating several break and enters over a few months including two that occurred on the 13th and 15th February 2021 at the Pioneer Gas Station in Port Hope where cigarettes were targeted.

As a part of the ongoing investigation between Port Hope Police Service Criminal Investigations Bureau, Uniform officers, Toronto Police Service Major Crime and Intelligence Units, Halton Police Service Criminal Investigations Bureau and Durham Regional Police Service Criminal Investigations Branch, a 33-year-old Toronto area female was identified as one of the involved persons.

On the 23rd February 2021 she was arrested by Toronto Police Service for a number of crimes throughout the Central and Central East Regions including the mentioned Gas Station break ins. She was held in custody pending a bail hearing.

It should be noted all of the gas station break and enters were resolved. There were two different groups of accused identified. The second group was a copycat group.

➤ **Fraud**

A young woman in the community fell victim to a fraud. The woman received a phone call from a "Jason Brown" badge # SIM4464802. Brown claimed to be from the Department of Justice. The male provided a phone number of 905-858-2637 which is the Newmarket courthouse. According to Brown he told the victim her SIN card was involved in an identity theft crime in south border Nunavut involving money laundering, drug smuggling, and opening up different bank accounts under BMO, CIBC, RBC, and TD. The victim was told if she did not verify who she was all her accounts would be frozen for six (6) months. The victim was later transferred to a Senior Federal Officer with the name of "Mark Hamilton". The victim was told to follow their instructions and transfer money from her visa and line of credit. She was instructed to attend a bit coin machine in the Oshawa Ontario area as it was the only government approved bit coin machine, and due to Covid all the Government buildings were closed. The victim was told to stay on the phone with Hamilton and not to speak to anyone. The victim was given instructions on how to complete the transactions through the bit coin machine. The victim completed two transactions using the bit coin machine which totaled \$7,000.00. She was then transferred to another male with the name of "William White" who instructed the victim \$300.00 more dollars was required to clear her name. She was later told court was closed and they were not able to clear her name and another transaction of \$1200.00 dollars was required which the victim completed. It was not until the victim returned back home to Port Hope she realized it seemed odd and telephoned her parents.

➤ **Stunt Driving**

Driver charged with Stunt Driving and Fail to Surrender Driver's License.

On the morning of September 9, 2021, while on foot patrol downtown Walton Street, Port Hope Police Officers observed a motor vehicle driving on Queen Street, and turned North onto Walton Street, squealing tires. Officers observed the same vehicle go around another vehicle on Walton Street at Ontario Street, again squealing tires.

Officers located vehicle shortly after and as a result of the investigation, 21-year-old male of Whitby was charged with the following:

1. Drive motor vehicle-perform stunt contrary to section 172(1) of the Highway Traffic Act.
2. Driver fail to surrender license contrary to section 33(1) of the Highway Traffic Act.

The driver was issued a 7-day License Suspension, and a 7-day Vehicle Impoundment. Vehicle impoundment for Racing/Stunt/Contest driving offenses, will increase from 7-day Vehicle Impoundment, to 14-day Vehicle Impoundment.

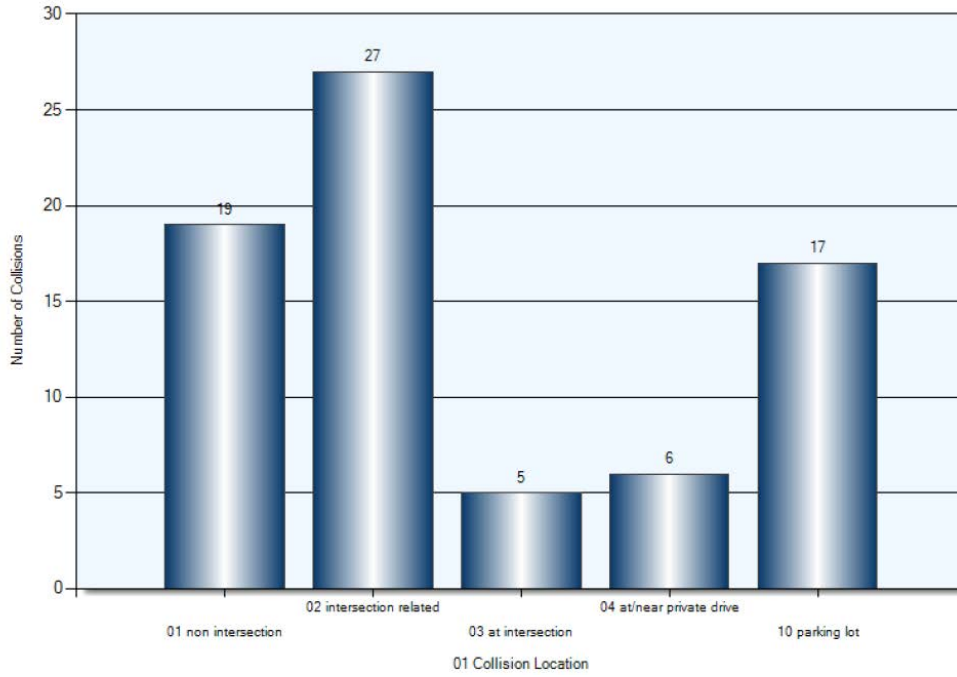

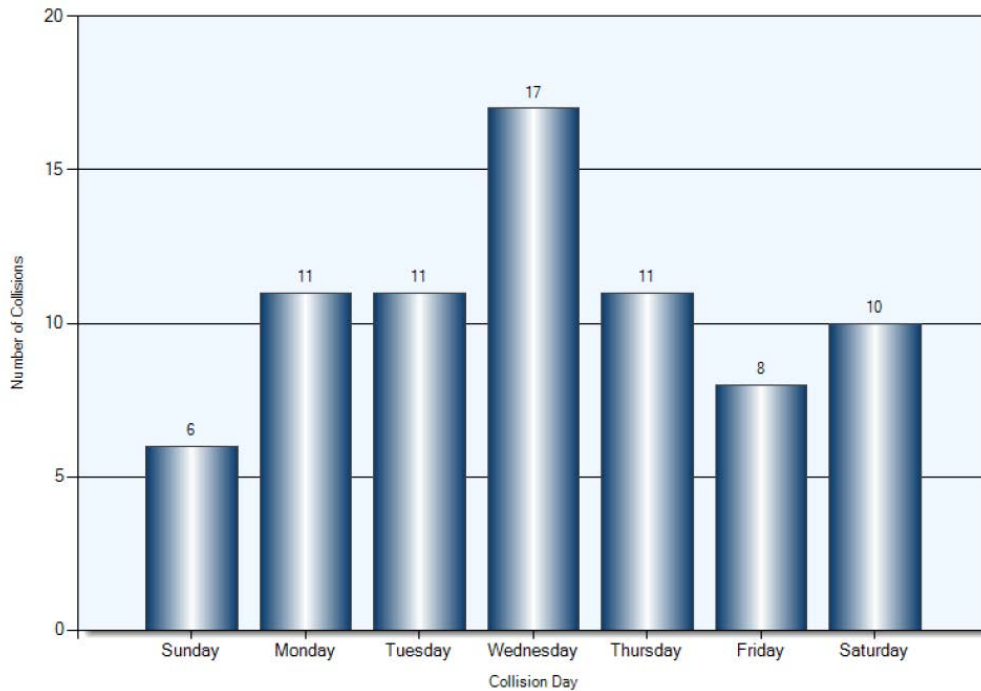

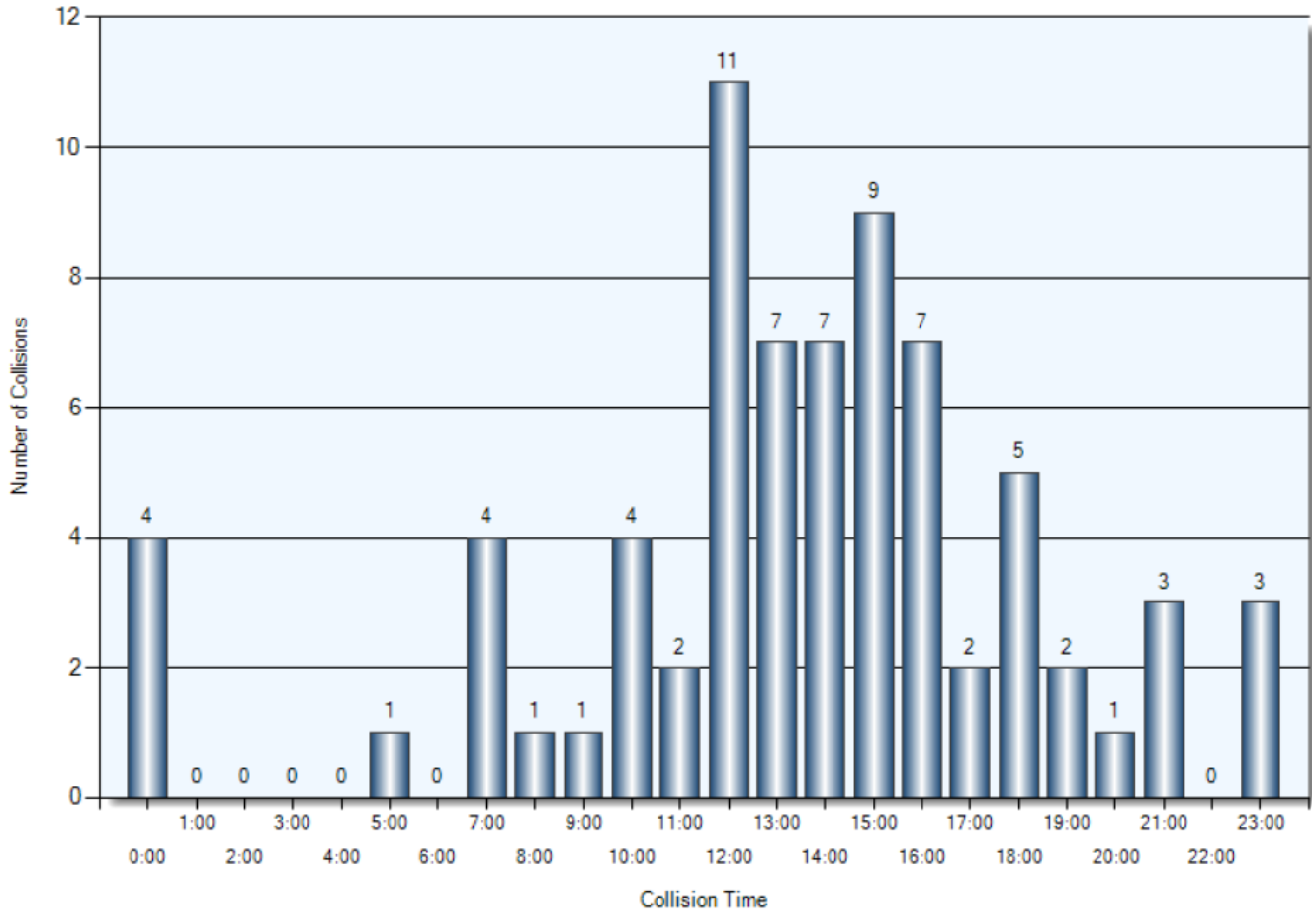
Collision Day



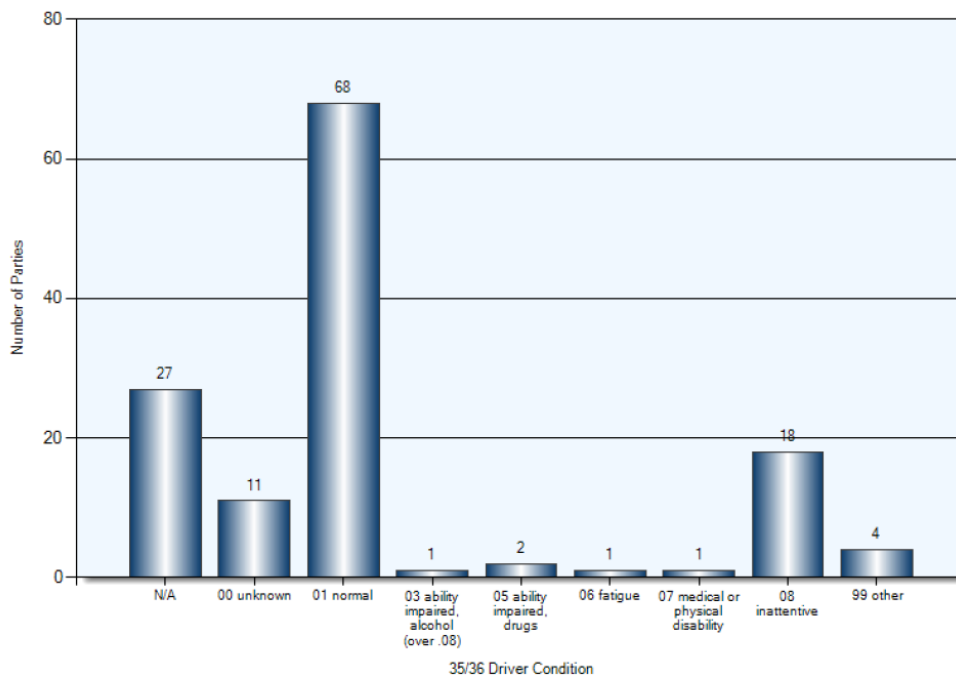

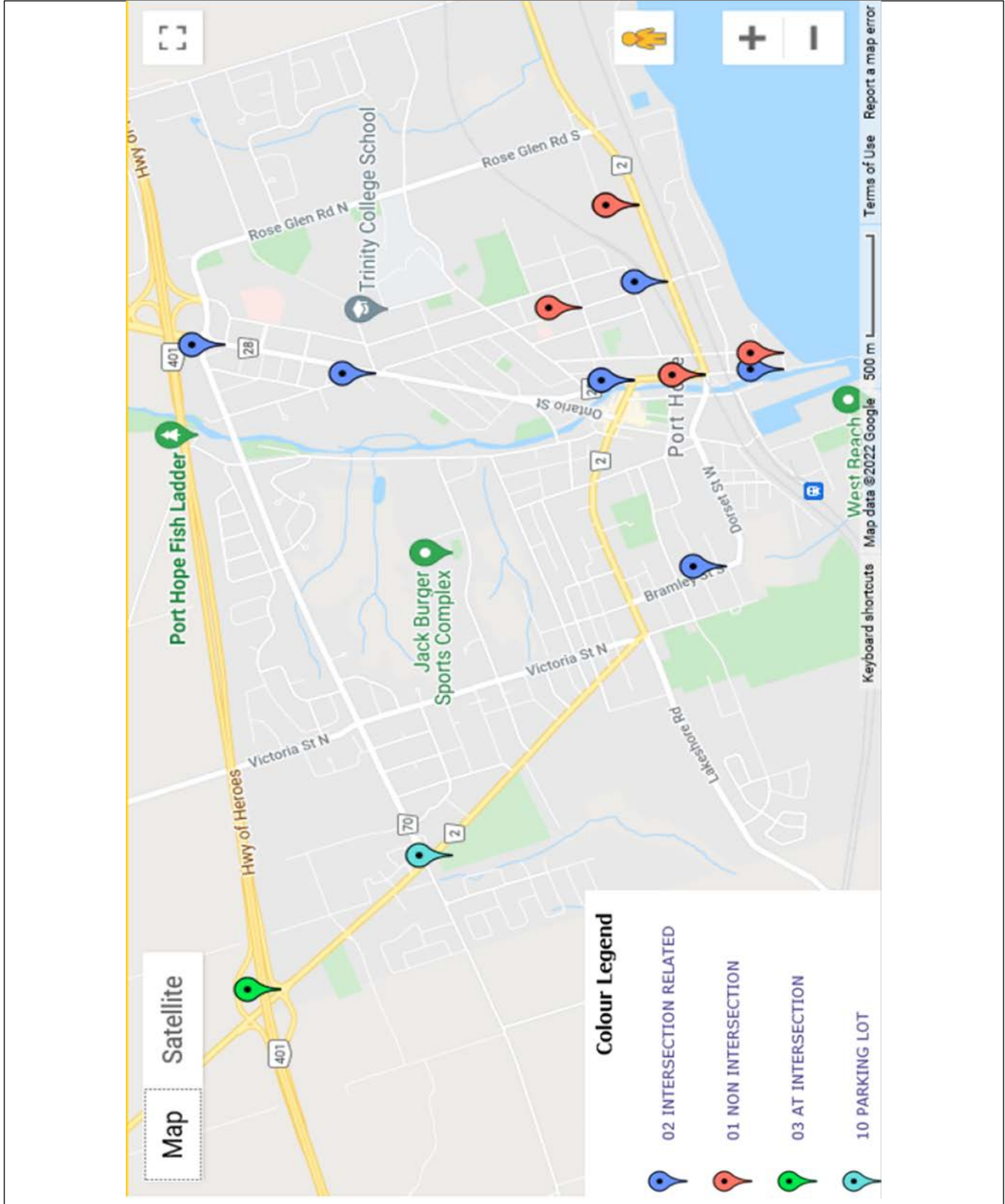
Driver Conditions

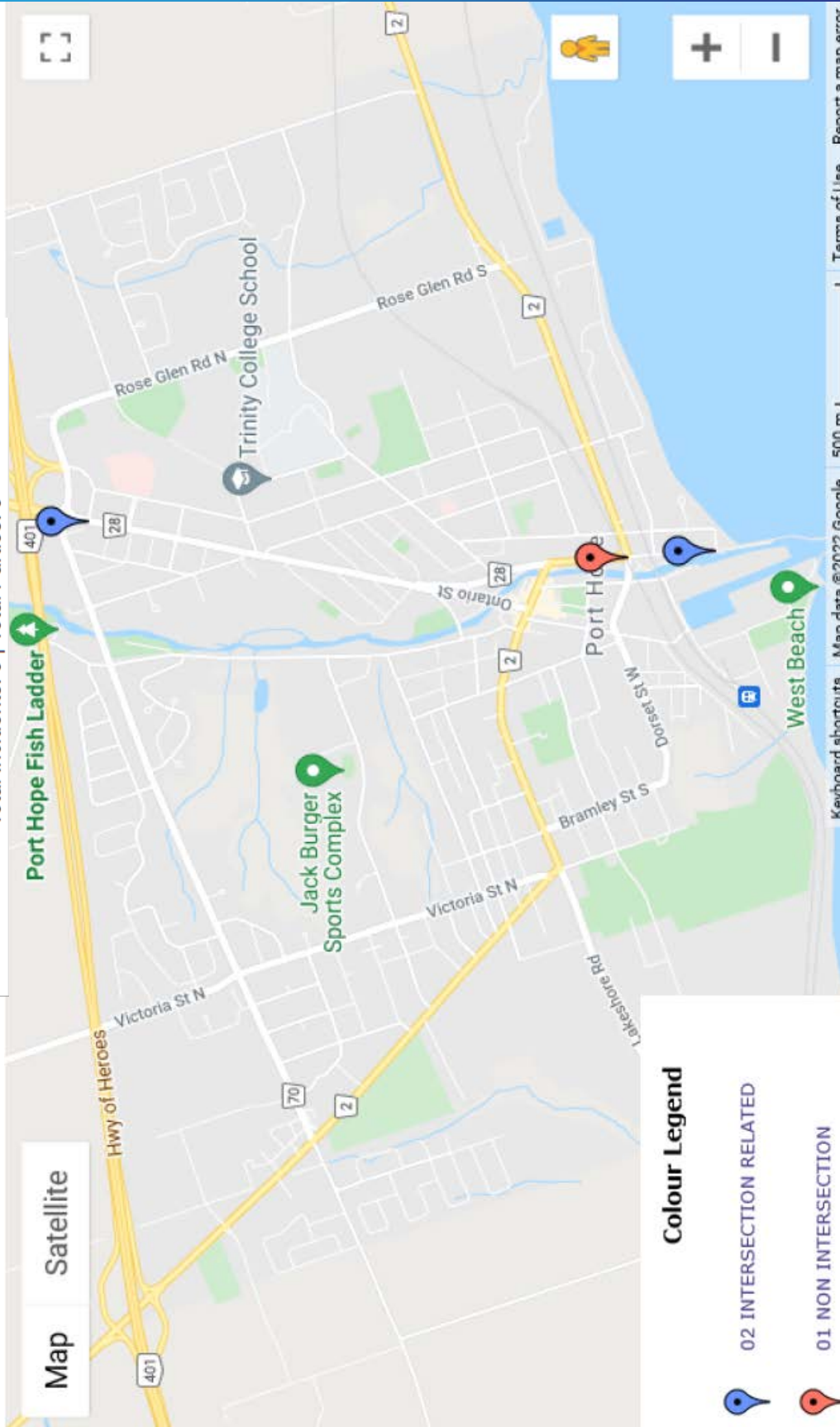




Collisions Involving Pedestrians

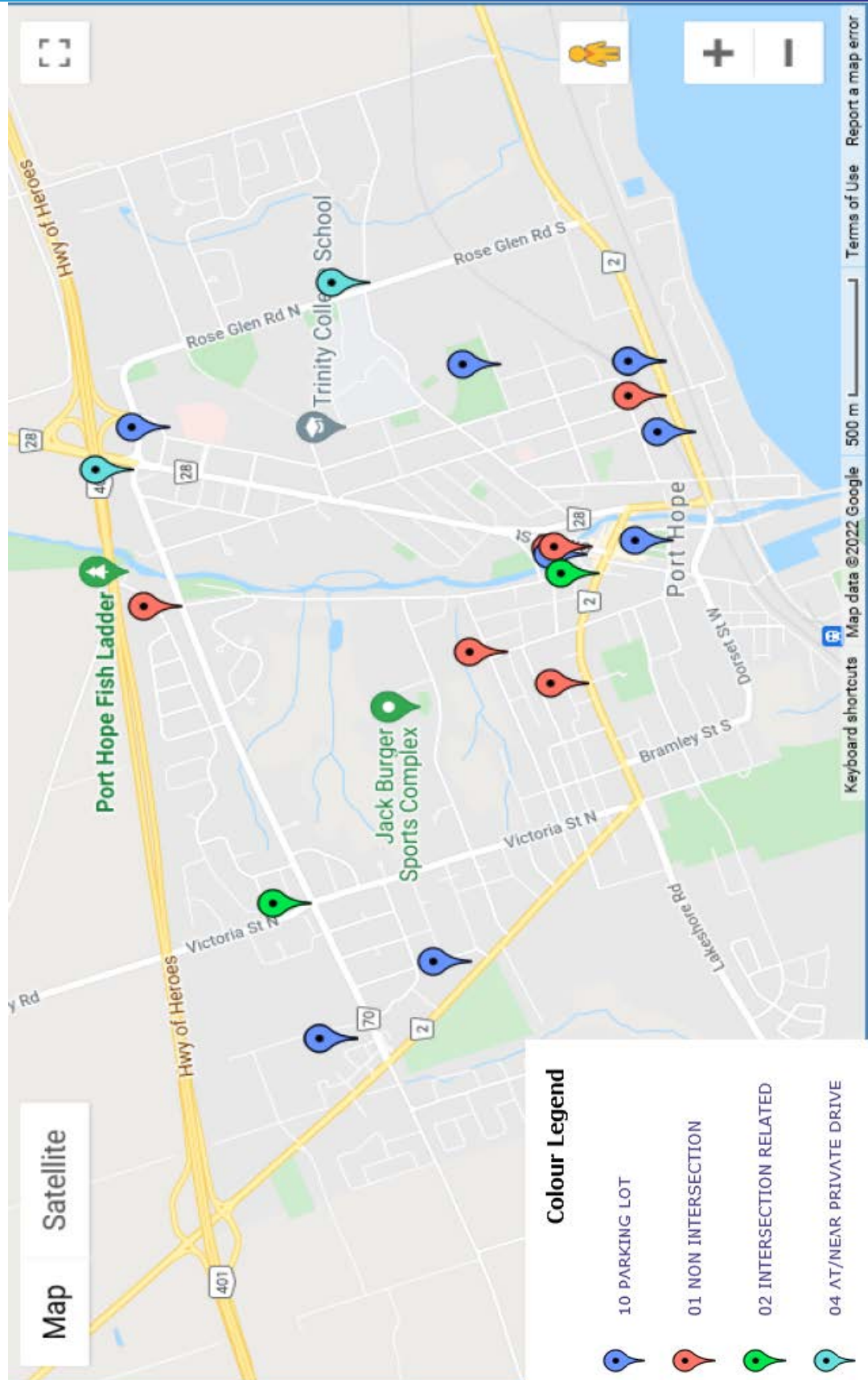

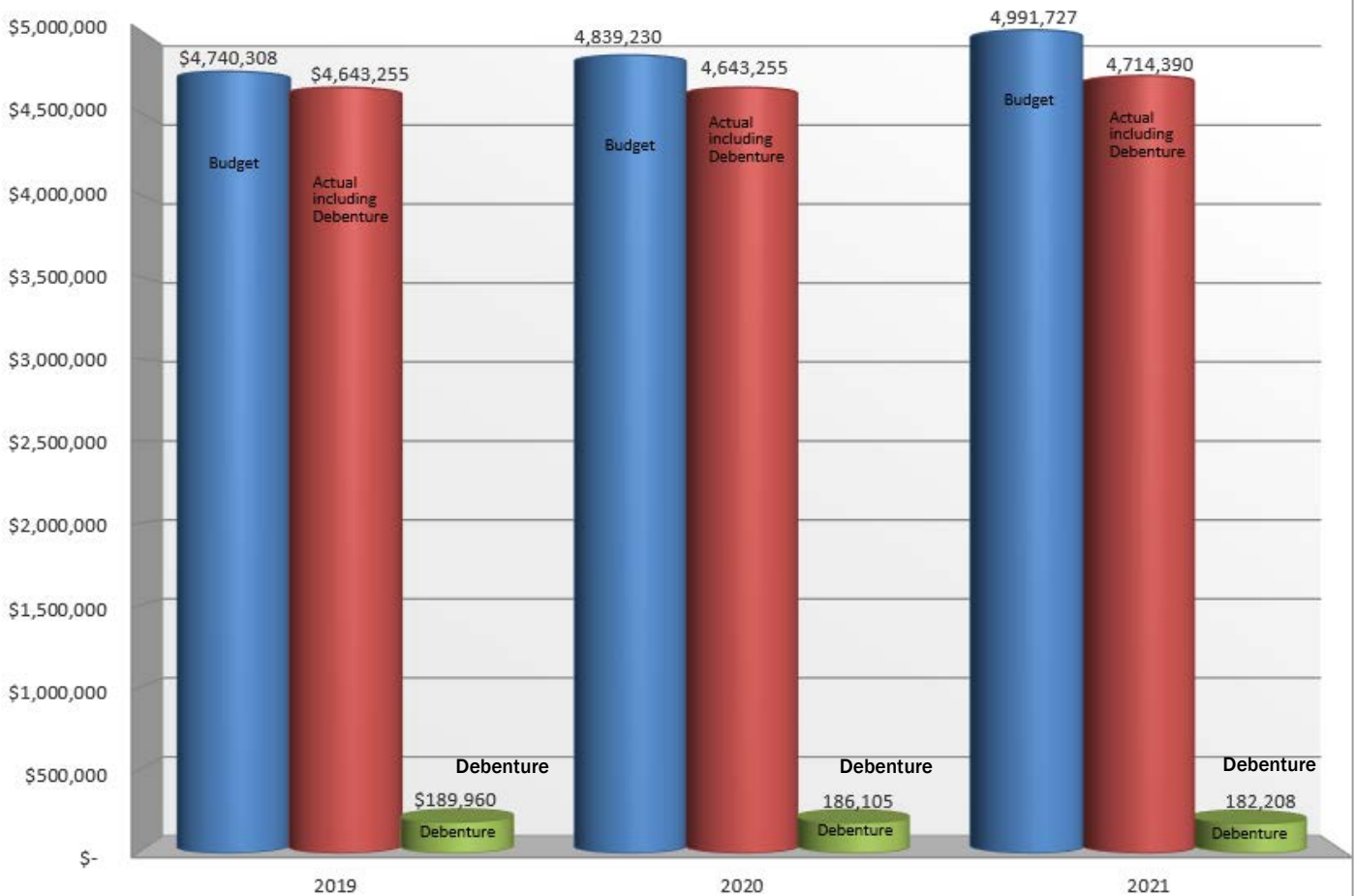
Financials:

The 2021 Port Hope Police Service (PHPS) budget highlights are based on preliminary internal statements as external audited year-end financial statements were not finalized at the time of this report. This section does not include screening revenue or expenses, see page 30 for screening data. Overall the Police service was under budget with a surplus of about \$277,337 at the writing of this report.

Revenue: Actual revenue \$109,788 was below the budgeted amount of \$123,315 the transfer from the reserve was not complete at the time of this report. Due to the pandemic Port Hope Police responded to all False alarm calls but did not bill for the false alarms.

Expenses: In total 2021 expenses were \$4,824,178 compared to a budget of \$5,115,042; PHPS was under budget. A large portion of the surplus came from officers being off on WSIB and a from other payments that were not needed to be paid out. Overtime budget was over the budgeted amount due to staff shortages and covid coverage. Retiree benefits were lower than budgeted.

Capital: In 2021 the following capital projects were completed: A new Cruiser was purchased replacing an older vehicle. Installation of a third flagpole, starting of the Auxiliary program, IT upgrades which included Office and video disclosure.





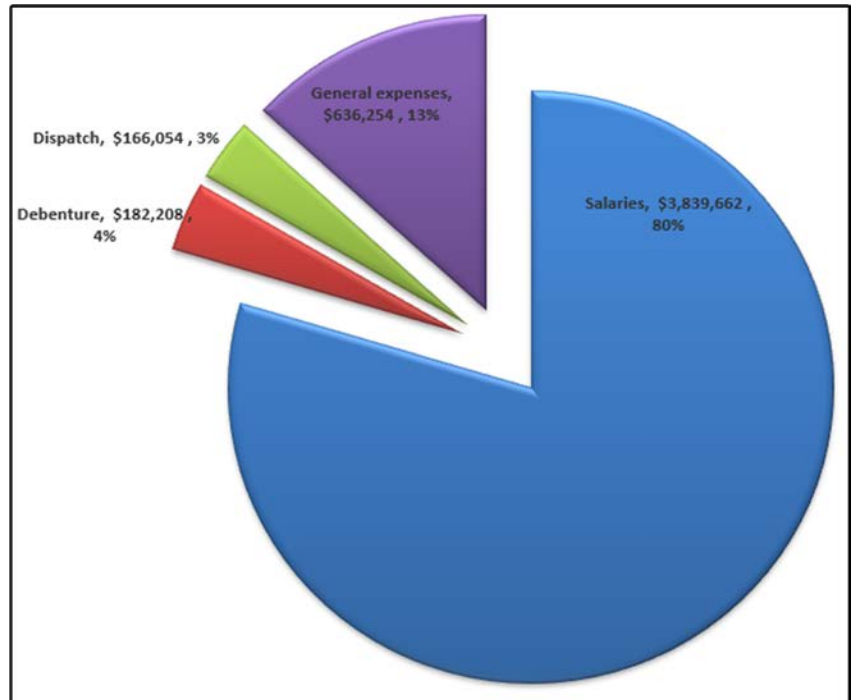

**Breakdown of expenses for 2021

80% of the 2021 budget went to salaries. Salaries are negotiated between the Port Hope Police Board and the Port Hope Police Association. This has been consistent in the last few years

General expenses are items such as heat, hydro, gas, vehicle expenses, building maintenance, information technology maintenance agreements and other items which made up 13% of the annual expenses.

The debenture made up 4% of the expenses in 2021 and Dispatch 3%.

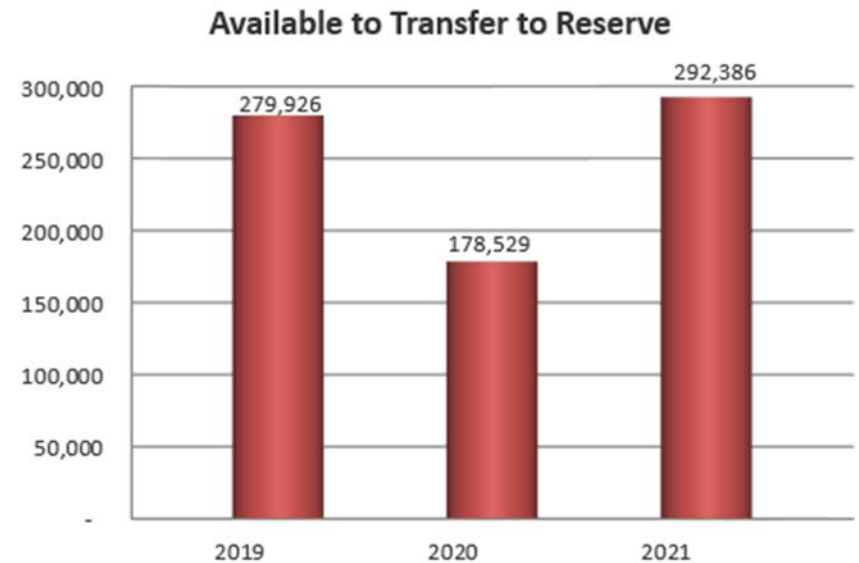


**Screening:

Port Hope Police Service has a number of clients for which third party criminal record checks are done. In 2021 the background checks are done mostly for employment purposes. After the slow year in 2020 due to the pandemic it was good to see revenue up again.

In 2021 Screening posted revenues of \$492,265 against expenses of \$199,879 which resulted in a profit, available to transfer of \$292,386 to the municipal policing reserve. This was the largest transfer to reserve since 2014.

Monies from the municipal policing reserve are used to fund police capital items such as police cruisers, guns, body armour, speed signs and to offset operating capital as determined by the Port Hope Police Service Board.

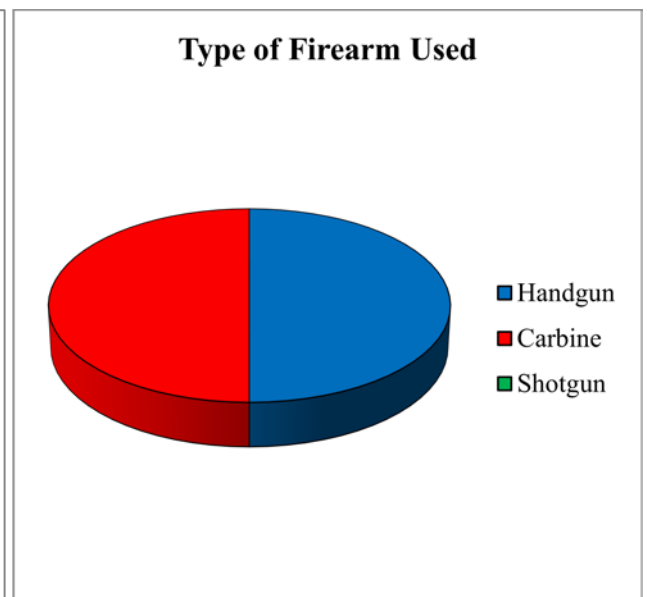
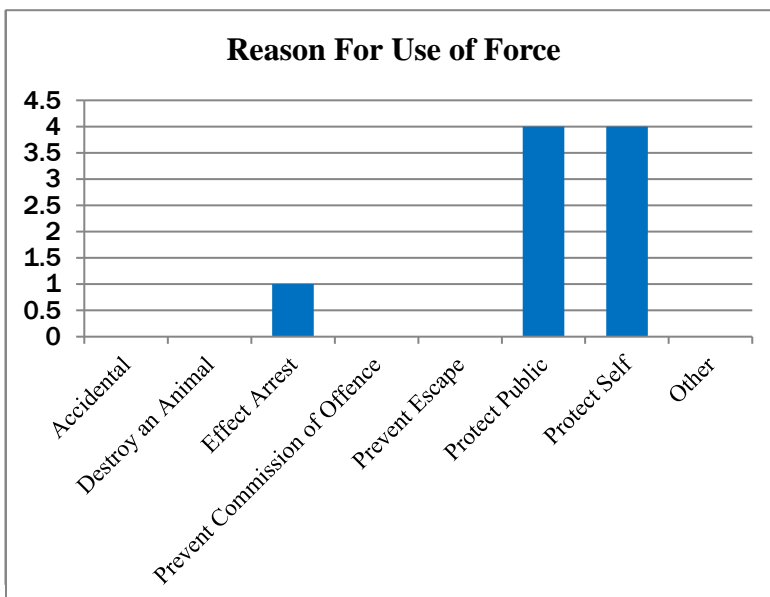
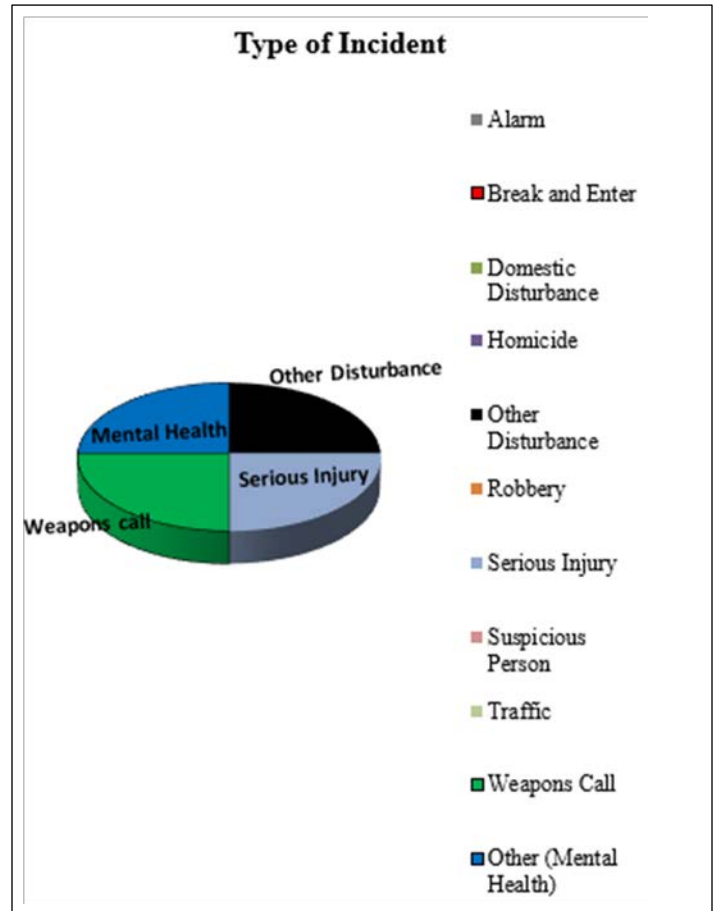
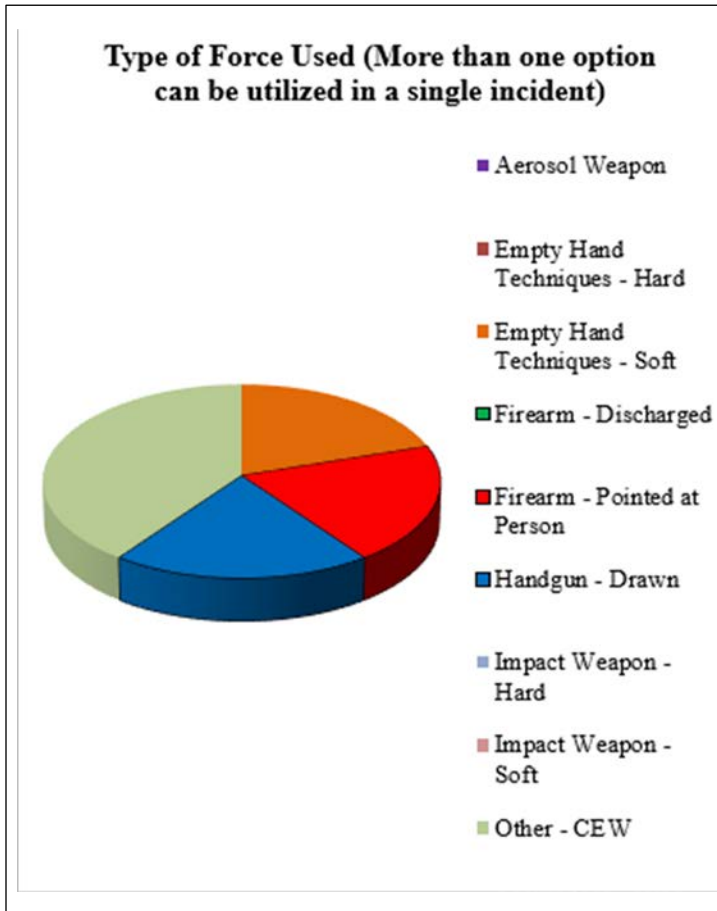

Three officers are committed to investigating public complaints. As required under the Police Services Act, Part V, investigators for the Port Hope Police Service are the Staff Sergeant, Sergeant in charge of the Criminal Investigations Unit and a Frontline Sergeants. The Inspector is the liaison with the Office of the Independent Review Director.
